## AMENDMENT TO RESOLUTION 2018-137 APPROVING ADDITIONAL VICTIM-WITNESS ASSISTANCE PROGRAM GRANT FUNDING

## RESOLUTION NO.

WHEREAS, on the 2<sup>nd</sup> day of October 2018, the Board of Supervisors approved Resolution Number 2018-137, whereby the Board approved the submission by the District Attorney of an application to the California Office of Emergency Services (hereinafter, "CalOES") for a Lake County Victim-Witness Assistance Program Grant in the amount of \$251,156 (hereinafter, the "Grant"); and

WHEREAS, said application also obligated the County to remit payment of up to \$31,688 in matching costs, which costs have now been reduced by CaIOES to \$6,338; and

WHEREAS, since the adoption of Resolution Number 2018-137, the District Attorney's Office has become aware of additional available Grant funding through CalOES in the amount of \$100,000 which requires additional matching funds of \$5,000; and

WHEREAS, said additional funding is available for the purposes of funding a Mass Victimization Advocate (MVA); and

WHEREAS, the District Attorney's Office acknowledges and agrees that the Mass Victimization Advocate will be a limited term position completely dependent on the existence of these specific MVA funds.

NOW THEREFORE, BE IT RESOLVED, that the above recitals are hereby adopted as true and correct and that the Office of the Lake County District Attorney is authorized, on the County's behalf, to submit the application for the additional funding for the purposes of funding an MVA position pursuant to the terms and conditions specified hereinabove; and

BE IT FURTHER RESOLVED that upon award of the grant by CalOES, the County of Lake authorizes the Lake County District Attorney to accept, in the name of the County of Lake, the award agreement and any extensions and amendments thereto. It is agreed that total grant reimbursable costs up to \$351,156 with matching funds of up to \$11,338 will be incurred during the grant period and will be appropriated according to the program guidelines set forth by CalOES and the grant award documents; and

BE IT FURTHER RESOLVED that in all other respects Resolution Number 2018-137 remains in full force and effect.
