- 4. The parties mutually agree to this amendment as follows. All actions noted below are by this reference made a part of the Agreement and incorporated herein:
 - A. Std. 213, Original Agreement, Paragraph 2, is hereby amended to read: Extend the termination date by six months, from December 31, 2018 to June 30, 2019. The term of this agreement begins on June 1, 2017 and terminates on June 30, 2019. This time extension will allow the contractor to complete work that was delayed due to natural disasters (e.g. storms, fires).
 - B. Std. 213, Original Agreement, Paragraph 3, is hereby amended to read: Increase the maximum amount payable by \$24,009.94 from \$41,075.00 to \$65,084.94. The maximum amount payable under this Agreement shall not exceed \$65,084.94. Due to natural disasters affecting the project site, repairs costs had to be increased.
