- WHEREAS,** Jill Shaul was hired as a Specialist Clerk by Lake County Special Districts on October 7, 1985, advancing to an Office Assistant II on October 6, 1986; and
- WHEREAS,** Jill worked above class as a Utilities Inventory Technician until she became a Customer Service Technician I on June 21, 1992, soon after taking on the above class duties of the Accounting Technician; and
- WHEREAS,** Jill advanced to a Customer Service Technician II on July 18, 1993 and eventually became the Customer Service Coordinator on January 18, 2005; and
- WHEREAS,** Jill received an Outstanding and Dedicated Service Employee of the year award in 1994; and
- WHEREAS,** Jill served as the recording secretary for the Resource Management Committee under Chair Karan Mackey, the Clearlake Advisory Subcommittee and the Water and Land Resources Subcommittee for ten years; and
- WHEREAS,** Jill served as the construction meeting recording secretary for the Southeast Geysers Effluent Pipeline project as well as the Southeast Inflow and Infiltration project from inception to completion; she also served as the recording secretary for the Seismic Monitoring Activity Committee; and
- WHEREAS,** under Special Districts Administrator Steve Brodnansky, Jill organized a committee of seventeen Clear Lake water purveyors in order to complete the first Watershed Sanitary Survey on March 31, 1996; and
- WHEREAS,** Jill has facilitated successful completion of numerous water and wastewater mainline extension projects including the Soda Bay Road Big Valley Wastewater project, the Clearlake State Park waterline extension, the Twin Pines Casino and Running Creek Casino wastewater mainline extensions, the Harbin Hot Springs wastewater mainline extension and many others; and

WHEREAS, Jill has established a professional relationship with both the Lake County real estate community as well as local and out of county contractors; and

WHEREAS, Jill has established meaningful, constructive working relationships with various county departments including the Department of Public Works, the Community Development Department, the Department of Environmental Health, the Department of Public Services, County Counsel and the Board of Supervisors Administrative Office; and

WHEREAS, Jill has been a valuable asset to the Human Resources Department by serving on many interview panels, which resulted in the hiring of dedicated and reliable county employees; and

WHEREAS, Jill has cultivated strong, mutually respectful working relationships and has provided support on many levels to all Special Districts employees, both in the office and in the field

WHEREAS, Jill has shown exemplary dedication to the service of Lake County Special Districts; and
