**RESOLUTION AUTHORIZING AMENDMENT A01 TO THE STANDARD AGREEMENT  
BETWEEN THE COUNTY OF LAKE AND THE DEPARTMENT OF HEALTH CARE  
SERVICES FOR SUBSTANCE ABUSE BLOCK GRANT FUNDS FOR THE PERIOD  
BETWEEN JULY 1, 2017 THROUGH JUNE 30, 2020 AND AUTHORIZING THE  
BEHAVIORAL HEALTH ADMINISTRATOR TO SIGN THE AMENDMENT**

**RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF LAKE,  
STATE OF CALIFORNIA, THAT IS FINDS, DETERMINES AND HEREBY DECLARES that  
Amendment A01 to the Standard Agreement (“STD 213”) between the County of Lake and the  
Department of Health Care Services (DHCS) for Substance Abuse Block Grant funds is hereby  
agreed upon by both the Contractor and the Department of Health Care Services.**

**WHEREAS,** the purpose of Amendment A01 is to modify some of the original terms and  
conditions in the Standard Agreement and to increase funding for Fiscal Year 2018-19; and

**WHEREAS,** Paragraph 3 on the face of the original STD 213, entitled, “**Maximum Amount  
Payable**” is increased by \$424,498 for Fiscal Year 2018-19 and is hereby amended to read as follows:  
“**\$2,047,741 (Two Million, Forty Seven Thousand, Seven Hundred Forty One Dollars)**”; and

**WHEREAS,** Paragraph 4 on the face of the original STD 213, which listed the incorporated  
Exhibits, is hereby amended to add **Exhibit A, Attachment 1A1**, entitled “**Program Specifications**”  
which replaces **Exhibit A, Attachment 1**, entitled “**Program Specifications**” in its entirety; and

**WHEREAS,** Paragraph 4 on the face of the original STD 213, which listed the incorporated  
Exhibit, is hereby amended to add **Exhibit B A1**, entitled “**Budget Detail and Payment Provisions**”  
which replaces **Exhibit B**, entitled “**Budget Detail and Payment Provisions**” in its entirety; and

**WHEREAS**, Paragraph 4 on the face of the original STD 213, which listed the incorporated Exhibits, is hereby amended to add **Exhibit B, Attachment 1 A1**, entitled “**Funding Amounts**” which replaces **Exhibit B, Attachment 1A1**, entitled “**Funding**” in its entirety; and

**WHEREAS**, Paragraph 4 on the face of the original STD 213, which listed the incorporated Exhibits, is hereby amended to add **Exhibit F, A1**, entitled “**Privacy and Information Security Provisions**” which replaces **Exhibit F**, entitled “**Privacy and Information Security Provisions**” in its entirety; and

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors of the County of Lake hereby authorizes the Behavioral Health Administrator to sign said Amendment A01 to the Standard Agreement on behalf of the County. A certified copy of this Resolution shall be delivered to the Lake County Auditor/Controller and the Department of Behavioral Health.
