**RESOLUTION APPROVING THE SALES ORDER AND SERVICES AGREEMENT
BETWEEN THE COUNTY OF LAKE AND CERNER CORPORATION FOR THE
PURCHASE AND MAINTENANCE OF THE CERNER INTEGRATED BEHAVIORAL
HEALTH SYSTEM KNOWN AS MILLENNIUM FOR THE TERM OF JANUARY 1, 2019
THROUGH JUNE 30, 2026 AND AUTHORIZING THE BEHAVIORAL HEALTH SERVICES
ADMINISTRATOR TO SIGN THE SALES ORDER AND THE SERVICES AGREEMENT**

RECITALS

WHEREAS, the Board of Supervisors of the County of Lake approved the sales order and services agreement grant between the County of Lake and the Cerner Corporation for the purchase and maintenance of the Cerner Integrated Behavioral Health System known as Millennium for the term of January 1, 2019 through June 30, 2026; and

WHEREAS, the approval of the sales order allows Lake County Behavioral Health Services (LCBHS) to purchase the Cerner Integrated Behavioral Health System known as Millennium which is an upgrade to our current Cerner system known as Anasazi; and

WHEREAS, the approval of the sales order allows LCBHS to secure a time slot in the future to guarantee the integration of the two (2) Cerner Behavioral Health systems; and

WHEREAS, the approval of the services agreement allows Cerner Corporation to provide maintenance of the new behavioral health system known as Millennium.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Lake, State of California hereby approve and adopt:

- a. LCBHS is approved to move forward with the sales order with Cerner Corporation for the purchase of the Cerner Behavioral Health System known as Miilieunam.
- b. LCBHS is approved to move forward with the services agreement with Cerner Corporation for the maintenance of the Cerner Behavioral Health System known as Millennium.
- c. LCBHS Administrator is approved to sign the sales order and the services agreement with Cerner Corporation.
- d. A certified copy of this Resolution shall be delivered to the Lake County Auditor/Controller and the Behavioral Health Services department.
