The applicant must meet the Lake County Division of Environmental Health requirements regarding on-site wastewater treatment and potable water requirements.

There is currently 1 (one) OWTS on the parcel designed to service a 2 bedroom mobile home. The applicant has proposed to replace the 2 bedroom mobile with a 2 bedroom manufactured home. The applicant will need to apply for a minor repair to install outlet sanitary tees, risers and connect sewer pipe from tank to manufactured home. An authorization inspection was completed by our office on May 2, 2018.

The applicant also proposes to install an additional Onsite Wastewater Treatment System (OWTS) to accommodate the new proposed commercial greenhouse. A site evaluation has been conducted by our office and the site is approved for a standard OWTS.

The applicant must meet the Lake County Division of Environmental Health setback requirements to the on-site wastewater treatment system and/or wells, streams, intermittent streams, and ponds.

The applicant will need to demonstrate the location of the existing and proposed wastewater systems, wells, existing structures and the location of the proposed project on a to-scale site plan prior to building permit issuance and/or project approval.

Lake County Environmental Health requires all applicants to provide a written declaration of the chemical names and quantities of any Hazardous Material to be used on site. As a general rule, if a material has a Safety Data Sheet, that material may be considered as part of the facilities Hazardous Material Declaration.
