RESERVE ADJUSTMENTS

<u>BU 1120 – Non Departmental Revenue</u>

The Budget Stabilization Reserve is being requested to increase due to the sale of a surplus property known as the Lucerne Hotel. (More information below under revenues BU 1120)

BU 4121 - Solid Waste

Solid Waste's reserves are being requested to be increased by \$836,000 for the future expansion of facilities.

REVENUES

BU 1120 – Non Departmental Revenues

As your Board is aware, closure of escrow on the \$2,500,000 sale of the Lucerne Castle is scheduled to take place soon. With this in mind, staff proposes placing proceeds from the sale into your Budget Stabilization Reserve and the adjustments you are considering today reflect that recommendation. You may recall that said reserve established by your Board for the purpose of incrementally reducing reliance on one-time funds to balance the budget. This reserve will be essential, as we weather the financial crisis we are facing in the years to come.

BU 1123 - Assessor

Lake County was selected to participate in the State Supplementation for County Assessors Program and Lake County was awarded \$60,000.

BU 1451 - Registrar of Voters

The California Secretary of State has allocated Lake County \$246,000 for the replacement of our current voting system, which requires a dollar-for-dollar match. Additionally, \$10,000 has been allocated for cyber security and \$10,000 for polling place accessibility that do not require a County match.

BU 1892 – Marketing & Economic Development

Lake County was allocated \$75,000 by the State to perform activities related to Census 2020.

BU 2601 – Agricultural Commissioner / Sealer

Unanticipated revenue from the unrefundable gas tax in the amount of \$82,333.

BU 2704 – Emergency Services

Recommended adjustments include unanticipated revenue from the FY 2017/2018 Homeland Security Grant in the amount of \$139,563.

BU 4121 - Solid Waste

Recommended adjustments include unanticipated revenue from fire debris disposal in the amount of \$1,200,000.

BU 5011 – Social Services Administration

The Social Services Department is requesting to increase overall revenue projections by \$838,733. The reason for the adjustments are related to changes in allocations from the State and Federal government.

APPROPRIATIONS

BU 1012 – County Administrative Office

Appropriations are being requested to be increased for Board-approved executive recruitments, leadership training, and BOS chambers upgrades.

BU 1123 - Assessor

The Assessor's office is requesting a \$60,000 increase to appropriations to utilize the new grant funds by hiring temporary employees through a temp agency.

BU 1451 – Registrar of Voters

Registrar of Voters is requesting new appropriations in the amount of \$492,000 for the replacement of our current voting system, which includes the required a dollar-for-dollar match. Additionally, \$10,000 for cyber security and \$10,000 for polling place accessibility that do not require a County match. As noted under BU 1451 on page 1, \$266,000 of the requested appropriations are State funded.

BU 1671 – Buildings & Grounds

\$170,000 is being requested to perform necessary upgrades and maintenance including HR office remodel, Elevator repair, and Probation roofing.

BU 2602 – Building & Safety

Requested new appropriations include two new vehicles for field staff and completion of the office remodel that was started under the previous department head.

BU 2704 – Emergency Services

The unanticipated FY2017 Homeland Security Grant revenue will be utilized for EOC equipment.

BU 1123-Assesor

Assessor is requesting the addition of two Auditor-Appraiser I/II/III positions. Once these two positions are filled, the remaining two Auditor-Appraiser I/II/III positions will be eliminated upon vacancy.

BU 1451 - Elections

Elections is requesting to convert one of their .75 time Elections Assistant I/II positions to full time.

BU 2113 – Victim Witness

Victim Witness is requesting the addition of one limited term position for a grant-funded project.
