LAKE LOCAL AGENCY FORMATION COMMISSION

A Resolution Making Determinations and Approving the Dissolution of the Adams Springs Water District, County Service Area 7 (Bonanza Springs), County Service Area 18 (Starview), and County Service Area 22 (Mt. Hannah)

WHEREAS, Resolution 8-17 Initiating the proceedings for a reorganization including the dissolution of the Adams Springs Water District, County Service Area 7 (Bonanza Springs), County Service Area 18 (Starview), and County Service Area 22 (Mt. Hannah) and amending the Boundary of the Cobb Area County Water District to include the service areas of the Adams Springs Water District, Alpine Meadows Water System, Pine Grove Water System, County Service Area 7, County Service Area 18, County Service Area 22; and [annexing the territory, properties, and all associated customers served by the] Branding Iron Mutual Water Company, and Hill 9 and 10 Mutual Water Association was filed with the Executive Officer of the Lake Local Agency Formation Commission pursuant to the requirements of the Cortese-Knox-Hertzberg Local Government Reorganization Act (Section 56000 *et seq* of the Government Code); and

WHEREAS, the County of Lake and the Cobb Area County Water District both support this dissolution and annexation; and

WHEREAS, the Executive Officer has provided notice of this hearing as described under Government Code Sections 56151 through 56159; and

WHEREAS, the Executive Officer reviewed the application and determined its completeness within 30 days of their submission and prepared and filed his report with this Commission at least five days prior to the regularly scheduled meeting during which this application is to be considered; and

WHEREAS, this Commission has considered the application, the report of the Executive Officer, the applicable General Plan, and each of the factors required by Government Code Section 56668 to be considered in the review of a proposal; and

WHEREAS, it is desired that the proposed dissolution of the Adams Springs Water District, County Service Area 7 (Bonanza Springs), County Service Area 18 (Starview), and County Service Area 22 (Mt. Hannah) totalling 2,536.41-acres more or less be subject to terms and conditions as follows:

1. The Cobb Area County Water District shall agree to defend, indemnify, and hold harmless the Lake Local Agency Formation Commission and its agents, officers and employees from any claim, action or proceeding against the Commission or its agents, officers, and employees; including all costs, attorney's fees, expenses and liabilities incurred in the defense of such claim. Action, or proceeding to attack, set aside, or void the approval or determinations of this Commission concerning this

10. As stated in the LAFCO Staff Report of May 16, 2018, the amount of base property tax and tax increment transferred shall be in accordance with Lake County and Cobb Area Resolution 2018-60 is attached as Exhibit C.
11. The Commission hereby adopts the Notice of Exemption included as part of the Executive Officer's report for this dissolution the applicant shall be responsible for payment of any documentary handling fees required by the Lake County Clerk/Auditor.
12. The subject proposal is assigned the following short form designation: Dissolution of the Adams Springs Water District & Cobb Area CSA's (LAFCo File 2017-0001).
12. The Executive Officer of this Commission is instructed to transmit a certified copy of this resolution to those persons so indicated on the application and as required by Government Code Section 56882.
13. The application for the Dissolution of the Adams Springs Water District, County Service Area 7 (Bonanza Springs), County Service Area 18 (Starview), and County Service Area 22 (Mt. Hannah) (LAFCO 2017-0001) is hereby approved subject to the terms and conditions herein.
14. The effective date shall occur upon recordation of the Certificate of Completion, which shall be recorded concurrently with the Certificate of Completion for the Cobb Area Water District Reorganization #1.
15. Upon the effective date of this dissolution control of all monies or funds including cash on hand and monies due but uncollected, and all property, real and personal, of the dissolved district is vested with the County as provided for in Government Code section 57457.
16. This dissolution shall not take effect until all conditions included in LAFCo Resolution 2018-0005 (Annexation to the Cobb Area County Water District including the Adams Springs Water District, Alpine Meadows Water System, Pine Grove Water System, County Service Area 7, County Service Area 18, County Service Area 22; and [annexing the territory, properties, and all associated customers served by the] Branding Iron Mutual Water Company, and Hill 9 and 10 Mutual Water Association) have been satisfied and a concurrent Certificate of Completion has been recorded.
17. Upon recordation of the Certificate of Completion, the authority of the Adams Springs Water District, County Service Area 7 (Bonanza Springs), County Service Area 18 (Starview), and County Service Area 22 (Mt. Hannah) to provide water services is hereby transferred to the Cobb Area County Water District entirely, and the Cobb Area Water District is hereby designated as the "successor agency" to the Adams Springs Water District, County Service Area 7 (Bonanza Springs), County Service Area 18 (Starview), and County Service Area 22 (Mt. Hannah) with respect to such water services. The Cobb Area County Water District shall succeed to all licenses, permits and authorities and all obligations and responsibilities of the water services within the Adams Springs Water District, County Service Area 7 (Bonanza Springs), County Service Area 18 (Starview), and County Service Area 22 (Mt. Hannah).

NOW THEREFORE, BE IT RESOLVED, pursuant to Section 99 and 99(b) of the Revenue and Taxation Code, Lake County ("County") has negotiated with Cobb Area County Water District ("District"), the County of Lake, and Adams Springs Water District and agrees to the following:

3. The base property tax and increment allocated to County Service Area 7, Bonanza Springs will not be apportioned or paid to the District as a result of the annexation and reorganization; and the negotiated agreement with County Services Area 7 is for "zero" exchange of property tax.
4. Base Property Tax: The base property tax revenue currently allocated to the County General Fund and all local taxing agencies shall not be changed as a result of this reorganization.
5. Future Incremental Property Tax: The future incremental property tax allocated to the County General Fund and all local taxing entities shall not be changed as a result of this reorganization.
6. This determination is made with prejudice to any future jurisdictional changes and does not establish a precedent for making determinations pursuant to Section 99 of the Revenue and Taxation Code.
7. The Clerk of the Lake County Board of Supervisors is directed to file a copy of this resolution to the Lake Local Agency Formation Commission, the County Administrative Office, the Auditor of Lake County and the Cobb Area County Water District.

BE IT FURTHER RESOLVED, the Lake County Administrative Officer, is hereby authorized to sign any documents pertaining to implementation of the resolution and to act as the Board of Supervisors representative in above related property tax exchange matter.

WHEREAS the Cobb Area County Water District (CACWD) has filed an application to annex 2,955.31-acres more or less into the Cobb Area County Water District known as LAFCO File 2017-0001 the Cobb Area Reorganization #1.

WHEREAS, The annexation includes 2,955.31-acres more or less and is described and depicted in Exhibits "A 1-87" Descriptions and "B 1-8" Maps, attached hereto and incorporated herein and filed with the Executive Officer of the Lake Local Agency Formation Commission pursuant to the requirements of the Cortese-Knox-Hertzberg Local Government Reorganization Act (Section 56000 et seq of the Government Code); and

WHEREAS, the CACWD was formed in 1961 to provide domestic water and wastewater services as provided for in section 30000 et seq. of the California Water Code; and

WHEREAS, the Cobb Area County Water District has concurrently filed an application to dissolve County Service Area 7 (Bonanza Springs), County Service Area 18 (Starview), County Service Area #22 (Mt Hannah) and the Adams Springs Water District totaling 2,536.41-acres more or less; and

WHEREAS, This annexation (reorganization) will be recorded concurrently with the dissolution of County Service Area 7 (Bonanza Springs), County Service Area 18 (Starview), County Service Area #22 (Mt Hannah) and the Adams Springs Water District.

WHEREAS, the Executive Officer reviewed the application and determined its completeness within 30 days of their submission and prepared and filed his report with this Commission at least five days prior to the regularly scheduled meeting during which this application is to be considered; and

WHEREAS, The Cobb Area County Water District adopted Resolution 8-17 pertaining to this reorganization; and

WHEREAS, this Commission has considered the application, the report of the Executive Officer, the Notice of Exemption (Class 20 and General Rule) for the

County and Cobb Area Resolution 2018-60 is attached as Exhibit C and Property Tax Revenue Exchange Agreement with Cobb Area County Water District Resulting from Annexation of Water Service Areas approved by both the Cobb Area County Water District Board of Directors on May 2, 2018 and the Board of Supervisors on May 8, 2018 attached hereto as Exhibit "D". Corrected Maps and Descriptions for Exhibit "D" are attached to this resolution as Exhibits "A 1-8" Boundary Descriptions and "B 1-8" Maps

9. Said reorganization territory is found to be inhabited.
10. The subject proposal is assigned the following short form designation: Cobb Area CWD Reorg. #1 (LAFCO File 2017-0001).
11. The boundaries of the affected territory are found to be definite and certain.
12. The application for this reorganization including dissolution of CSA's 7, 18, and 22 and the Adams Springs Water District and concurrent annexation to the Cobb Area County Water District (LAFCO 2017-0001) is hereby approved to provide domestic water services within the territory subject to the terms and conditions herein. This reorganization is consistent with the sphere of influence for the Cobb Area County Water District as adopted on March 21, 2018.
13. LAFCo is the conducting authority for this reorganization. In accordance with the provisions of Section 57000 of the Government Code and with Lake LAFCo Policies, the Commission hereby directs the Executive Officer to schedule a protest hearing for this matter after the expiration of the reconsideration period specified by Section 56895; to conduct the hearing for this reorganization; and, upon completion of the hearing, to take action as appropriate in accordance with LAFCo Policies and the requirements of Chapter 3, Part 4 of Division 3 of the California Government Code.
14. All Cobb Area County Water District previously authorized assessments; taxes, fees and charges shall apply to this annexed territory upon recordation of the Certificate of Completion.
15. All LAFCO, Lake County and State of California fees must be paid in full prior to filing the Certificate of Completion. LAFCO will forward invoices and (or) a list of estimated required fees or deposits to the agency prior to filing the Certificate of Completion.
16. All terms and conditions included in Cobb Area County Water District Resolution 8-17 shall be satisfied prior to recordation of the Certificate of Completion.
17. The authority of County Service Area 7 (Bonanza Springs), County Service Area 18 (Starview), County Service Area #22 (Mt Hannah) and the Adams Springs Water District to provide water services is hereby transferred to the Cobb Area County Water District entirely, and the Cobb Area County Water District is hereby designated as the "successor agency" to County Service Area 7 (Bonanza Springs), County Service Area 18 (Starview), County Service

2.2. Service Plan

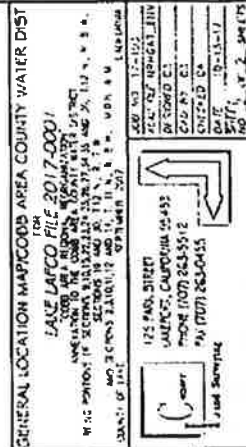
The Plan for Services provided by the CACWD shall determine the manner in which services are provided in the affected territory.

3. Acceptance by the Cobb Area County Water District

3.1 The Cobb Area County Water District shall submit a letter to LAFCo accepting all assets physical and financial assets, liabilities & leases within the reorganization territory.

18. This annexation shall be recorded concurrently with the Certificate of Completion for the Dissolution of County Service Area 7 (Bonanza Springs), County Service Area 18 (Starview), County Service Area #22 (Mt Hannah) and the Adams Springs Water District (LAFCo Resolution 2018-0004)
19. The effective date shall be the date the concurrent recording of the Certificate of Completion for both the County Service Area 7 (Bonanza Springs), County Service Area 18 (Starview), County Service Area #22 (Mt Hannah) and the Adams Springs Water District dissolution and the annexation of the territory to the CACWD. The effective date shall occur after completion of the LAFCo proceedings.
20. One electronic copy (PDF), five large copies (18 by 24 minimum) and two 8 1/2 x 11 reductions of all maps along with an electronic copy (PDF) and two copies of the final boundary description shall be submitted to LAFCO prior to recordation of the Certificate of Completion.
21. The Cobb Area County Water District may at its discretion, create benefit zones for separate financial rate structures, in order to retire legacy loans and bonded debt, or to create new loans and bonded debt for required system improvements, or simply for the management of discrete water systems, as necessary.
22. The legacy loan incurred by CSA #22 (Mt. Hannah) will be retired prior to its annexation by the Cobb Area County Water District.
23. The number of directors of the Cobb Area Water District shall be expanded from 5 to 7 as provided for in the California Water Code Division 12 Part 3, Chapter 1, Article 1 Section 30500.1(a). Unless otherwise provided for in the California Water Code, initial additional directors shall be appointed by the Lake County Board of Supervisors and elected at large thereafter.
24. Approval of this reorganization is conditioned upon the applicant's obligation to defend, indemnify, and hold harmless the Lake Local Agency Formation Commission and its agents, officers and employees from any claim, action or proceeding against the Commission or its agents, officers, and employees; including all costs, attorney's fees, expenses and liabilities incurred in the defense of such claim, action, or proceeding to attack, set aside, or void the

NOW THEREFORE, BE IT RESOLVED, pursuant to Section 99 and 99(b) of the Revenue and Taxation Code, Lake County ("County") has negotiated with Cobb Area County Water District ("District"), the County of Lake, and Adams Springs Water District and agrees to the following:

1. The Adams Springs Water District has no property tax entitlement, and therefore, there is no property tax base and increment to be transferred to the Cobb Area County Water District; and the negotiated agreement is for "zero" exchange of property tax.
2. County Service Areas 18 and 22 do not receive property tax entitlements from Lake County, and therefore, there is no property tax base and increment to be transferred to Cobb Area County Water District; and the negotiated agreements with County Services Areas 18 and 22 is for "zero" exchange of property tax.
3. The base property tax and increment allocated to County Service Area 7, Bonanza Springs will not be apportioned or paid to the District as a result of the annexation and reorganization; and the negotiated agreement with County Services Area 7 is for "zero" exchange of property tax.
4. Base Property Tax: The base property tax revenue currently allocated to the County General Fund and all local taxing agencies shall not be changed as a result of this reorganization.
5. Future Incremental Property Tax: The future incremental property tax allocated to the County General Fund and all local taxing entities shall not be changed as a result of this reorganization.
6. This determination is made with prejudice to any future jurisdictional changes and does not establish a precedent for making determinations pursuant to Section 99 of the Revenue and Taxation Code.
7. The Clerk of the Lake County Board of Supervisors is directed to file a copy of this resolution to the Lake Local Agency Formation Commission, the County Administrative Office, the Auditor of Lake County and the Cobb Area County Water District.

BE IT FURTHER RESOLVED, the Lake County Administrative Officer, is hereby authorized to sign any documents pertaining to implementation of the resolution and to act as the Board of Supervisors representative in above related property tax exchange matter.

**PROPERTY TAX REVENUE EXCHANGE AGREEMENT WITH COBB AREA COUNTY WATER DISTRICT
RESULTING FROM ANNEXATION OF WATER SERVICE AREAS**

THIS AGREEMENT is entered into by and between the County of Lake ("County"), a political subdivision of the State of California, and the Cobb Area County Water District ("District"), an independent special district located within the County.

RECITALS

WHEREAS, District has initiated proceedings with Lake Local Agency Formation Commission ("LAFCO") pursuant to LAFCO Application No. 2017-0001 "Application", proposing to annex those certain unincorporated areas shown on Exhibit A (Annexation Area") into the boundaries of the District; and

WHEREAS, if approved, the Annexation Area will result in the District consolidating and operating the water systems identified in said Application; and

WHEREAS, Section 99 of the Revenue and Taxation Code provides that upon the filing of an application for jurisdictional change, LAFCO's Executive Officer may not issue a Certificate of Filing on the application until the local agencies whose service areas or responsibilities will be altered should the annexation occur, reach an agreement as to the amount, if any, of property tax revenues to be exchanged among them; and

WHEREAS, to the extent that it is applicable, Revenue and Taxation Code Section 99 provides that when a jurisdictional change such as annexation will affect special districts, the County Board of Supervisors shall negotiate an exchange of property tax revenues, if any, on behalf of the special districts that will be affected by the jurisdictional change. Pursuant to Revenue and Taxation Code Section 99.01(a)(3), the District has negotiated for the property tax revenue exchange on its own behalf; and

WHEREAS, the parties hereto have negotiated an exchange of property tax revenue and the District has agreed to that negotiated exchanged of property tax revenue as set forth in County Resolution No. 2018-60.

AGREEMENT

NOW, THEREFORE, County and District agree as follows:

Notice by personal delivery shall be effective immediately upon delivery. Notice by mail shall be effective upon receipt or three (3) days after mailing, whichever is earlier.

SECTION 8. Agreement or Consent. Wherever this Agreement requires a party's agreement or consent, the party shall make its decision to give or withhold such agreement or consent in good faith, and shall not withhold such agreement unreasonably or without good cause.

SECTION 9. Construction of Captions. Captions of the sections of this Agreement are for convenience and reference only. The words in the captions in no way explain, modify, amplify, or interpret this Agreement.

SECTION 10 Both parties agree that this Agreement and the rights and obligations hereunder is subject to and governed by the laws of the State of California in all respects as to the interpretation, construction, operation, effect, and performance.

SECTION 11. Effective Date. The County has authorized the execution of this Agreement by the Board of Supervisors, District has authorized its execution by its Board of Directors, on the dates set forth below. The Effective Date of this Agreement shall be on the date last authorized as indicated below:
