**RESOLUTION TO ESTABLISH A LIST OF PROJECTS PROPOSED TO BE FUNDED PURSUANT TO THE ROAD  
REPAIR AND ACCOUNTABILITY ACT OF 2017 (SB1)**

**WHEREAS**, the Road Repair and Accountability Act of 2017 (the "Act") will provide additional funding to support roads maintenance and rehabilitation and other eligible transportation purposes such as traffic control and drainage improvements; and

**WHEREAS**, the Act created Section 2034(a)(1) of the Streets and Highways Code which requires that prior to receiving an apportionment of funds pursuant to paragraph (2) of subdivision (h) of Section 2032 in a fiscal year, an eligible city or county shall submit to the California Transportation Commission (Commission) a list of projects proposed to be funded with these funds pursuant to an adopted city or county budget; and

**WHEREAS**, for Fiscal Year 2019-20, those projects identified on Exhibit A hereto reflect the list of projects proposed by Lake County to be funded from revenues generated pursuant to the Road Repair and Accountability Act of 2017 as allocated from the Act's newly authorized Road Maintenance and Rehabilitation Account.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors of the County of Lake, State of California, as follows:

1. The foregoing recitals are true and correct.
2. The projects delineated in Exhibit A hereto, are hereby adopted as those proposed to be funded from revenues generated pursuant to the Road Repair and Accountability Act of 2017 as allocated from the Act's newly authorized Road Maintenance and Rehabilitation Account.
