22	recommend based on the employee's extraordinary qualifications,
23	that the employee receive a salary step which is higher than that set
24	forth in subsections 1.4.1 and 1.4.2. Under such circumstances, the
25	Human Resources Director may authorize an advanced salary step at
26	Step 3. The County Administrative Officer may authorize an
27	advanced salary step at Step 4 or Step 5.
