## Scope & Proposal:

- 1. Disconnect and remove interior equipment from existing indoor panel. Retain existing panel can in place for use as a pull box and to refeed existing circuits.
- 2. Supply and install new 100 amp 240 volt single phase Nema 1 disconnect switch, to be mounted directly to the left of existing panel box inside the building. Switch to be lockable and used for the purpose of main disconnect.
- 3. Mount new customer supplied automatic transfer switch directly to the left of new main disconnect inside the building.
- 4. Supply and install new 100 amp 240 volt main lug only 12/24 Nema 1 loadcenter. New load center to be mounted inside the building near door.
- 5. Supply and install an 1 ¼" conduit with (3) #2 cu conductors and a #6 cu ground between existing panel (to be used as splice can), new main disconnect, new ATS, and new loadcenter.
- 6. Supply and install a new 1" conduit with (3) #4 cu conductors and a #8 cu ground from the new ATS to the generator.
  - a. New conduit will penetrate the exterior wall near the generator with a ridged steel nipple and transfer to liquid tight flexible conduit.
  - b. #12 conductors will be pulled in with the other power conductors to supply power to any battery charging circuit or block heater circuit.
- 7. Supply and install a new 3/4" conduit with low voltage start signal cable from the ATS to the generator.
  - a. New conduit will penetrate the exterior wall near the generator with a ridged steel nipple and transfer to liquid tight flexible conduit.
- 8. Core drill 2 holes for power and low volt conduits to pass through wall, fill back around conduits with non-shrink grout.

#### Excludes:

- 1. Any permits or fees to include but not limited to County, PG&E, or air quality.
- 2. Supply of new generator and automatic transfer switch.
- 3. Setting of new generator in place.
- 4. Fuel, or fuel line for generator.
- 5. Supply of generator battery or any fluids.
- 6. Factory start up.
- 7. Adding of any new circuits to the existing building.
- 8. Painting of conduits or electrical equipment.
- 9. Bonding of this project.
- 10. Any insurance beyond Coastal Mountain Electric's normal coverage.
- 11. Any new grounding,
