AGREEMENT

THIS AGREEMENT, made this 16th day of July, 2019, by and between COUNTY OF LAKE, hereinafter called "OWNER" and Maxwell Asphalt, Inc. doing business as, a Utah Corporation, hereinafter called "CONTRACTOR".

WITNESSETH: That for and in consideration of the payments and agreements hereinafter mentioned:

- (1) The CONTRACTOR will commence and complete the Lampson Field Airport Runway 10-28 Asphalt Slurry Seal Project, AIP NO. 3-06-0117-019-2018.
- (2) The CONTRACTOR will furnish all of the material, supplies, tools, equipment, labor and other services necessary for the construction and completion of the PROJECT described herein.
- (3) The CONTRACTOR will commence the work required by the CONTRACT DOCUMENTS within 15 calendar days after the date of the NOTICE TO PROCEED and will complete the same within Sixty (60) days total Thirty (30) calendar days for Mobilization and Thirty (30) working days unless the period for completion is extended otherwise by the CONTRACT DOCUMENTS.
- (4) The CONTRACTOR agrees to perform all of the WORK described in the CONTRACT DOCUMENTS and comply with the terms therein for the sum of \$1,005,710.00, as shown in the contractors BID.
