WHEREAS, on January 1, 2017, County of Lake, through its Department of Social Services, entered into the Standard Agreement #16-5022 with California Department of Social Services for zero dollars (\$0.00) from January 1, 2017 to June 30, 2019, to provide Resource Family Approval Program Services; and

WHEREAS, California Department of Social Services issued Amendment #A-1 to the Standard Agreement #16-5022 to increase the total amount to twenty seven thousand six hundred dollars (\$27,600.00) in order to reflect the cost of services provided from January 1, 2017 to June 30, 2019.
