### Stabilizing Special Conditions

- 1 PRS TO OBTAIN DIG ALERT NUMBER. CONTRACTOR TO PERFORM ALL UTILITY POTHOLE AND LOCATION AND GIVE PRS ADVANCED NOTIFICATION TO HAVE A PRS REPRESENTATIVE PRESENT DURING THESE OPERATIONS.
- 2 FDR-C Includes: Pulverize AC/Chip Seal pavement and blend with base/native to a depth of 12". Pulverized material to be left in place. Work to be completed in normal daylight working conditions in 3 shifts. Includes one mobilization.
- 3 FDR-C Includes: Furnish Portland Cement at a rate up to 5%, spreading, initial mixing and remixing to a depth of 12", water trucks for our work, initial compaction, and one mobilization.
- 4 Price is based on an in-place dry soil weight up to 125 P.C.F. Price will adjust if soil weight is higher. Rate of application and depth of treatment are for estimating purposes only and are not intended for design use. Price is good for 90 days from the date of this proposal unless otherwise agreed upon.
- 5 Price is based on TWO (2) shifts of pre-pulverization; THREE (3) spread and initial mix shift and compact shifts. Stated quantity will be considered minimum for billing purposes. If final quantity is less than the stated quantity, the full quantity will be billed and a credit for unused reagent will be issued.
- 6 MICRO-CRACKING Includes: 12-ton vibratory, steel drum roller, operated.
- 7 BALANCE GRADE AND FINISH GRADE Includes: Rough grade/balance pulverized material. Includes finish grade of FDR-C surface. Includes motor grader, skipper, roller and water truck.
- 8 OWNER to provide metered water source within 1,000 feet of the work area, with a minimum of 4,000 gallons every 20 minutes.
- 9 Processing area shall be free of all rocks larger than 3". Damage to equipment from buried objects to be billed at time and materials
- 10 Contractor to provide all necessary equipment to pull edges and corners and compact areas that are inaccessible to our equipment, such as, but not limited to, around manholes, risers and adjacent to curb and gutter and adjacent to utility crossings.
- 11 Excludes Posting, barricades, traffic control, flagging, engineering, mix design, testing, inspection, layout of work, earthwork, all grading, export of excess materials, mixing table maintenance, final compaction, microcracking, curing, dust control, street sweeping or cleanup of all travel ways. Also any S.W.P.P., USA notification, marking, locating or pot-holing for utilities - see "GENERAL CONDITIONS".

### General Conditions

ACCEPTANCE of this bid/proposal/quotation (Bid) from PAVEMENT RECYCLING SYSTEMS, INC. (PRS) requires that the PRICING, SPECIAL CONDITIONS and the GENERAL CONDITIONS of this Bid be included in any subcontract or purchase order agreement (Contract) and the Bid terms and conditions take precedence over any conflicting terms. PRS will not surrender any portion of extra work or force account mark-ups except those reserved by the owner for the General Contractor. California prompt pay statutes shall be enforced.

Unless otherwise defined in the SPECIAL CONDITIONS of this bid PRS excludes from the services quoted her all: MAINTENANCE AND PROTECTION OF THE COMPLETED PULVERIZED/TREATED SECTIONS, TRAFFIC CONTROL, SURVEYING, LAYOUT, SAWCUTTING AND DUST CONTROL. Upon completion of each segment of the designated work by PRS the work shall be deemed accepted and approved and the Customer shall assume maintenance and protection of the work. All utilities, obstructions, and foreign objects in the work zone must be marked and located by the Customer prior to PRS's work. PRS excludes any damage to unmarked or improperly located obstructions in the zone of work. PRS excludes notification to any underground alert service, marking or location of underground utilities. By accepting the Bid the Customer accepts sole responsibility for, and all subsequent liabilities coincident with the following requirements of the regional notification center law pursuant to Article 2 (commencing with Section 4216) of Chapter 3.1 of Division 5 of Title 1 of the California Government Code.

Any indemnity and defense obligation required from PRS shall be proportional and limited to the extent PRS's acts, omissions, fault or negligence contribute to any alleged or actual claims or damages. Insurance included in this Bid: Commercial Liability \$1MM per occurrence / \$2MM aggregate; \$2MM Products and Completed Operations Aggregate; \$1MM Personal and Advertising Injury; \$1MM Commercial Auto; Worker's Compensation coverage per statute.
