18	indigenous Tribal Nations - Middletown Rancheria of Pomo Indians of California, Koi
19	Nation of Northern California, Big Valley Band of Pomo Indians, Scotts Valley Band of
20	Pomo Indians, Habematolel Pomo of Upper Lake, Robinson Rancheria of Pomo Indians
21	of California and Elem Indian Colony; and
22	WHEREAS, the Board additionally desires, and finds it is in the best interest of
23	all concerned, to add Section 7 to Resolution No. 2018-127, thereby extending the term
24	of the herein referenced Agreement through December 31, 2019.
25	NOW, THEREFORE BE IT RESOLVED by the Board of Supervisors of the
26	County of Lake, State of California, that Resolution No. 2018-127 is hereby amended
27	as follows:
