WHEREAS, the Public Health Division of the Lake County Health Services

Department has received a letter for a local assistance award of real-time allotment
funding to support TB prevention and control activities in Lake County; and

WHEREAS, this funding is being awarded with the understanding that the Public Health Division will work with the California Department of Public Health Tuberculosis Control Branch in carrying out TB control efforts; and

WHEREAS, the Public Health Division will use this funding for allowable expenditures for TB patients which will include among other things, assistance with food, shelter, transportation as necessary to enhance treatment adherence, prevent homelessness and/or promote least restrictive alternatives that decrease or obviate the need for detention;

NOW THEREFORE, BE IT RESOLVED THAT, the Chair of the Board of Supervisors of the County of Lake is hereby authorized to sign said Certification Clause on behalf of the County of Lake.

BE IT FURTHER RESOLVED that the Director of Health Services is hereby authorized and empowered to execute in the name of County of Lake, State of California the acceptance of allotment paperwork, all necessary payment requests, hereto for the purposes of securing these funds to implement and carry out the purposes specified in the paperwork.
