WHEREAS, on September 17, 2019 the parties entered into Amendment No. 2 to include the Granicus Encoding Appliance Software; and

WHEREAS, the parties desire to amend the Agreement to add PEAK Agenda Management and Government Transparency Services under a 60 Day Pilot Program with the option to convert to this program at no extra cost to the County;

NOW, THEREFORE, the parties hereby agree as follows:

The subscription start date will begin on the date of the first Kickoff call and will continue for 12 months. During the pilot period Lake County CA will have the opportunity to evaluate the included Granicus Solutions (Solutions) and professional staff. After 60 days of experiencing the Solutions, an invoice will be processed for Lake County CA. If Lake County CA chooses not to proceed with the Solutions, Lake County CA must notify Granicus in writing of its intention not to proceed before the expiration of the 60-day pilot period. If Lake County CA chooses not to proceed with Peak subscription, the existing Legistar subscription will remain in effect.

Solutions may not be fully deployed within 60 days, but once the Kickoff call is complete, Granicus will move quickly to get tasks done, to allow Lake County CA sufficient time for evaluation of the Solutions. It is vital that Lake County CA respond quickly to requests for information, so Granicus can keep the project on time. The pilot does not allow for extensions or delays imposed by the Lake County CA team.
