To Whom It May Concern,

This letter is to oppose the prospective marijuana cultivation at 7560, 7540 & 7580 S. Highway 29, Kelseyville for the reasons below.

We retired here from Sonoma County and have lived in this home for 20 years. This is our dream home and we love the quiet location. The potential for robberies, violence and our personal safety that marijuana grows can bring, are of extreme concern to us.

One of us is very sensitive to odors and has allergies and asthma. Allergies require monthly injections and annual testing to keep them somewhat under control.

We are also highly concerned what this will do to our water supply. When the well was drilled for the vineyard above us, we noticed a decrease in the volume and quality of our water. We now have a lot of iron in our water.

The runoff from the far western sites appears to run straight to our pond on our property, which if they are using any type of chemicals and it is in the runoff it will flow to our pond. We observe wildlife drinking from the pond and waterfowl nesting near the pond. Our family dogs also drink from the pond.

Please do not allow this type of permit to grow marijuana next to our home.


