Two deaths have occurred on our property from a mid air collision during unsafe flying conditions. One plane crashed 300 feet from her house the other about 600 feet ,I would like to be involved with all discussions regarding the airstrip and it's proposed usage .

> We are a 4th generation cattle ranch that started in 1950 ,also hay crops and farming is our livelihood ,we support the livestock and ranchers of southern lake County with feed .

> Back in or around 2008 I attended all of the 20 year plan meetings for southern Lake Co, the glider port property of Jim and Conny Indibo was a main concern and topic in these meetings on the usage and how it would effect this farming and ranching community of Grange Rd .Former supervisor Jim Comstock is also my neighbor and longtime friend we both have the largest properties on Grange Rd. The Agricultural community must be preserved, all proposed developments need to be looked at very carefully .
