**Work Plan:**

The Work Plan is in reference to Cooperative Service Agreement (CSA) No. 18-7306-0256-RA. USDA-APHIS-WS will administer an Integrated Wildlife Damage Management (IWDM) program in Lake County. USDA-APHIS-WS will assist business/property owners, private citizens, and governmental agencies in protecting human resources, which include, but are not limited to, residents, property, livestock, crops, and natural resources from damage caused by predators, wild and feral animals, and other nuisance wildlife.

**Financial Plan:**

The cooperator will be billed quarterly by USDA-APHIS for actual costs incurred but will not exceed \$110,202.00 annually. An estimated itemization of expenses is listed below; however funds may be distributed between itemized categories at the discretion of USDA-APHIS-WS:
