Whereas, Health and Safety Code Sections 40001, 40702 and 40910 give the Lake County Air Quality Management District (District) the responsibility to adopt and enforce a program to maintain air quality that will continue to meet the federal and state Ambient Air Quality Standards; and

Whereas, the State of California Air Resources Board has funding to provide the District with non-match Carl Moyer Program grant funding; and

Whereas, the District intends to apply for and accept Carl Moyer Program funds; implement the program according to the laws and guidelines of the program; certify that adequate resources to carry the program out exist at the District; and, will designate the Air Pollution Control Officer as having authority to sign all program documents.

## NOW THEREFORE, BE IT RESOLVED, ORDERED AND DIRECTED that:

The District will accept Carl Moyer Program funds and implement the program according to the laws and guidelines of the program; and

- 1. That the Board authorizes the Air Pollution Control Officer to continue the District's participation in the Carl Moyer Program, including submittal of an application for Year 22 non-match funds and authority to sign all program documents for Year 22 funds.
- 2. That project contracts will be brought to the Board for authorization to sign, and
- 3. That the District continue to prioritize public agency projects, followed by projects accomplishing the conversion of diesel engines to a non-combustion source to include electrical line power, then all other projects on a first come first serve basis.
