Amendment No.1 TO THE AGREEMENT BETWEEN COUNTY OF LAKE AND MOTHER-WISE PROGRAM (PERINATAL MOOD AND ANXIETY DISORDERS) FOR FISCAL YEAR 2019-20

This Amendment No. 1 to Agreement is made and entered into this 1st day of April, 2020 by and between the County of Lake, a political subdivision of the State of California (hereinafter referred to as "County") Mother-Wise Program (hereinafter referred to as "Contractor").

RECITALS

WHEREAS, the parties hereto have entered into an Agreement dated July 1, 2019 under which Contractor will provide specialized mental health services to County; and

WHEREAS, the parties wish to amend that agreement to allow for additional compensation to be paid; and

NOW, THEREFORE, the parties hereto agree to the following amendment to be effective April 1, 2020

Section 3 – COMPENSATION is hereby amended to read as follows:

<u>"COMPENSATION"</u>. Contractor has been selected by County to provide the services described hereunder in Exhibit A. titled "Scope of Services". Compensation to the Contractor previously listed as not to exceed Sixty Five Thousand Dollars (\$65,000) shall now read One Hundred Eight Four Thousand Eight Hundred Sixty Two Dollars and Fifteen Cents (\$184,862.15).

Exhibit B, Section 4 – PAYMENT TERMS is hereby amended to read as follows:

"PAYMENT TERMS" County shall reimburse the contractor monthly upon receipt of the invoices from prior month's services, provided County receives invoices no later than the 10th day of the calendar month. Late receipt of invoices by the timeframes specified in Exhibit B, Section 2 or MHSA progress reports by the timeframes specified in Exhibit A, Section 2 of this agreement may delay payment of invoices. The monthly amount of the invoices should not total more than Forty Five Thousand Three Hundred Seventy Dollars and Seventy Two Cents (\$45,370.72) per month from April 2020 to June 2020. Please reference item 4.1, Mother-Wise 2019-2020 Annual Budget.
