

INMATE TELEPHONE AND VIDEO VISITATION SERVICES AGREEMENT
Amendment #1
Lake County Sheriff's Office

THIS FIRST AMENDMENT ("First Amendment") has an effective date of May 1, 2020 ("First Amendment Effective Date") between the County of Lake, a political subdivision of the State of California ("County") and Inmate Calling Solutions, LLC, d/b/a ICSolutions ("Vendor") with an address of 2200 Danbury Street, San Antonio, Texas, 78217.

WHEREAS, on October 1, 2017, County and Vendor entered into an Inmate Telephone and Video Visitation Service Agreement ("Agreement") under which Vendor agreed to install and operate all inmate and visitation telephones and video visitation equipment at the Lake County Jail – Hill Road Facility. The parties hereto desire to amend the terms of the Agreement to modify **SECTION 2. – TERM** and **Attachment B – FACILITY SPECIFICATIONS** as follows:

1. **SECTION 2. TERM** is hereby deleted in its entirety and replaced with the following:
 - 2.1. County and Vendor entered into an Inmate Telephone and Video Visitation Service Agreement on October 1, 2017 for an initial term of 3 years with an expiration date of September 30, 2020 ("Initial Term"). County exercises its right to further renew this Agreement for an additional 1-year term which shall begin October 1, 2020, and remain in force throughout the renewal term, with an expiration date of September 30, 2021 ("Renewal Term"). This Agreement shall not bind, nor purport to bind, County for any contractual commitment in excess of the Renewal Term. However, County, at its sole option, shall have the right to renew this Agreement for 1 additional 1 year term or on a month to month basis (not to exceed 12 months) prior to the expiration of the Renewal Term of this Agreement. In the event the County exercises such right, all terms and conditions, requirements, and specifications of this Agreement, and any Amendments, shall remain the same and apply during the renewal term(s). This Agreement will not automatically renew.
2. Effective with the First Amendment Effective Date, in accordance with the request from the County to install additional Video Visitation equipment, Attachment B - Facility Specifications is hereby amended to add the line item Inmate Mobile Video Visitation Station.

The original Agreement, as expressly modified by this First Amendment, is the complete agreement of the parties and supersedes all prior or contemporaneous agreements and representations whether written or oral and may not be further modified or amended except by written amendment.
