RESOLUTION TO AMEND THE ADOPTED BUDGET FOR FY 2019/2020 FUND 168 BUDGET UNIT 5011 SOCIAL SERVICES ADMINISTRATION BY APPROPRIATING UNANTICIPATED REVENUE IN THE AMOUNT OF \$100,000 AWARDED TO LAKE COUNTY FOR COVID-19 NON CONGREGATE SHELTERING AND AUTHORIZING THE SOCIAL SERVICES DIRECTOR TO SIGN AWARD RELATED DOCUMENTS

WHEREAS, Government Code Section 29130 provides that unanticipated revenue may be made available for specific appropriation by a four-fifths vote of the Board at any regularly scheduled or properly noticed special meeting; and

WHEREAS, pursuant to his March 4, 2020 proclamation of a state of emergency, Governor Gavin Newsom signed Executive Order N-32-20 on March 18, 2020 to provide local governments with emergency homelessness funds to expand immediate shelter and isolation capacity; and

WHEREAS, the Department of Social Services was recently awarded additional funding from the California Department of Social Services (CDSS) for non-congregate sheltering to support Project Room Key and to provide COVID-19 preventions to the homeless population in the amount of One Hundred Thousand and 0/100 cents \$100,000.00; and

WHEREAS, this funding will be used to support the Project Room Key program for the purposes of the lease and operation of a hotel to provide housing, meals and wraparound services to individuals who are affected by COVID-19 and do not have the means to isolate themselves due to homelessness as defined in program criteria

**WHEREAS**, it is necessary to appropriate said revenue into the Lake County Department of Social Services Budget to support this program.

**NOW, THEREFORE, BE IT RESOLVED THAT**, the Director of Social Services is hereby authorized and empowered to execute in the name of the County of Lake, State of California all necessary certifications, contracts, payment requests, agreements, and amendments hereto for the purposes of securing these funds to implement and carry out the purposes specified in the award letter.

BE IT FURTHER RESOLVED THAT THE BOARD OF SUPERVISORS OF THE COUNTY OF LAKE, STATE OF CALIFORNIA, that it finds, determines, and hereby declares that the county of Lake Adopted Budget for the Fiscal Year 2019/2020 is amended as follows:
