- The proposed 2019-2027 Housing Element amendment is consistent with the provisions of the California Government Code and is consistent with the State General Plan Guidelines.
- 2. The Board of Supervisors further finds that the amendments to the Housing Element are consistent with the Lake County General Plan.
- 3. The Board of Supervisor hereby adopts 2019-2027 Housing Element Update, attached hereto as Exhibit A, amending the General Plan Housing Element in its entirety.
- 4. The Board of Supervisors hereby finds that the Housing Element Update is consistent with State Law.
- 5. The Board of Supervisors hereby directs staff to submit the 2019-2027 Housing Element amendment to the California Department of Housing and Community Development (HCD) for review pursuant to state law. The Planning Director is further directed to make any technical or clerical changes to the Housing Element as may be required to address any comments from HCD.
