Amendment No. 1 to the Agreement between the Lake County Watershed Protection District and Davis Environmental for Environmental Site Assessment Services for the Middle Creek Flood Damage Reduction and Ecosystem Restoration Project

This Amendment No.1 to Agreement is made and entered into this _____ day of ______, 2020, by and between the Lake County Watershed Protection District, hereinafter referred to as "DISTRICT", and Davis Environmental, hereinafter referred to as "CONSULTANT".

RECITALS

WHEREAS, the District entered into Agreement No. 4600012946 dated July 2, 2019 with the State of California Department of Water Resources (DWR) accepting \$15,000,000 in grant funding for the Middle Creek Flood Damage Reduction and Ecosystem Restoration Project (Project); and

WHEREAS, funds from Agreement No. 4600012946 are to be used for the acquisition of property from willing sellers that will be affected by the Project; and

WHEREAS, in order to use funds from Agreement No. 4600012946, an Environmental Site Assessment (ESA) must be approved by DWR for each parcel being acquired prior to an appraisal; and

WHEREAS, the District entered into an Agreement dated February 11, 2020 for the lump sum fee of \$18,550 with Davis Environmental for Phase 1 Environmental Site Assessments for thirty-two (32) parcels for the Middle Creek Flood Damage Reduction and Ecosystem Restoration Project (Project); and

WHEREAS, there are an additional remaining twenty-three (23) parcels in the Project Area needing to have an ESA completed not outlined in the current Agreement; and

WHEREAS, in order to complete the Middle Creek Flood Damage Reduction and Ecosystem Restoration Project, all parcels located within the Project Area need to have an ESA completed prior to being acquired by the DISTRICT; and

WHEREAS, CONSULTANT has been conducting ESA services for the Project since February, 2020 and records of CONSULTANT's performance on this Project have been exemplary.

NOW, THEREFORE, the parties hereby agree as follows:

A. CONSULTANT has been selected by DISTRICT to provide services described hereunder in Exhibit A, titled "Scope of Services" which includes one (1) expedited Phase 1 ESA for five (5) priority parcels and two (2) Phase 1 ESA's for eighteen (18) parcels for a lump sum fee of twenty four thousand and five hundred fifty and no cents. (\$24,550). The Parties agree that all other terms and conditions of the original Agreement shall remain in full force and effect.

Davis Environmental Phase I ESA Proposal County of Lake June 1, 2020 The Phase I Environmental Site Assessments will be conducted adhering to ASTM E 2247-16, *Standard Practice for Environmental Site Assessments: Phase I Environmental Site Assessment Process for Forestland or Rural Property.* The Phase I Environmental Site Assessments will be limited to those areas of inquiry included under ASTM E 2247-16.

SCOPE OF SERVICES
