AMENDMENT No. 2 TO THE AGREEMENT BETWEEN COUNTY OF LAKE - LAKE COUNTY BEHAVIORAL HEALTH SERVICES AS LEAD AGENCY FOR THE LAKE COUNTY CONTINUUM OF CARE AND KELSEYVILLE UNITED METHODIST CHURCH AS THE FISCAL AGENT FOR THE HOPE HARBOR WARMING CENTER PROJECT FOR FISCAL YEAR 2019-20

Amendment No. 2 to Agreement is made and entered into thisday of
by and between the County of Lake, (hereinafter referred to as "County")
and Kelseyville United Methodist Church, hereinafter referred to as "Contractor", collectively
referred to as the "parties".

RECITALS

WHEREAS, the parties hereto entered into an Agreement dated April 1, 2020 under which Contractor will provide temporary shelters and services to reduce the spread of COVID-19 among the homeless population during Fiscal Year 2019-20; and,

WHEREAS, the parties agreed to Amendment No. 1 of the aforementioned Agreement on May 1, 2020 to increase total compensation payable by \$79,511.74, to bring the total compensation amount up to \$152,664.66 for the period April 1, 2020 through June 30, 2020; and,

WHEREAS, the parties now desire to again amend the aforementioned Agreement for one additional month, from July 1, 2020 through July 31, 2020, during Fiscal Year 2020-21.

NOW, THEREFORE, the parties hereby agree as follows:

- 1. The title of the aforementioned Agreement is hereby amended to read as follows:
 - "Agreement Between the County of Lake Lake County Behavioral Health Services as Lead Agency for the Lake County Continuum of Care and Kelseyville United Methodist Church as the Fiscal Agent for the Hope Harbor Warming Center Project for Fiscal Year 2019-2020 and 2020-21".
- 2. Article 3 of the aforementioned Agreement is hereby amended to read as follows:
 - "COMPENSATION. Contractor has been selected by County provide the services described hereunder in Exhibit A Scope of Services for a maximum compensation of One Hundred Fifty Two Thousand Six Hundred Sixty Four Dollars and Sixty Six Cents (\$152,664.66) for the period April 1, 2020 through June 30, 2020 and Seventy-Nine Thousand Dollars and Zero Cents (\$79.000) for the period July 1, 2020 through July 31, 2020. "
- 3. Article 1 of Exhibit B of the aforementioned Agreement is hereby amended to read as follows:

"Agreement Amount

The total amount of this Agreement shall not exceed 231,664.44. "

The Parties agree that all other terms and conditions of the original Agreement shall remain in full force and effect.
