**A RESOLUTION AMENDING RESOLUTION NO. 2020-72 AND THE POSITION ALLOCATION
CHART FOR FISCAL YEAR 2020-21 ESTABLISHING POSITION ALLOCATIONS FOR
FISCAL YEAR 2020-2021, BUDGET UNIT NO. 1920, DISASTER RESPONSE AND

RESOLVED by the Board of Supervisors of the County of Lake, State of California, that it finds,
determines, and hereby declares that:

1. Resolution No. 2020-72 is hereby amended to be effective August 21, 2020 as follows:
 - a. The position allocation for Budget Unit No. 1920, Disaster Response & Recovery, shall be amended to change one (1) on Accountant-Auditor I/II/III, Accountant-Auditor I/II/III CPA to one (1) Emergency Event Data Evaluation Program Manager, Unit 1 grade B25 to address additional disaster finance needs as a result of COVID-19, CARES Act, and enhanced organizational needs of this budget unit.
