WHEREAS, Government Code Section 29130 provides that unanticipated revenue may be made available for specific appropriation by a four-fifths vote of the Board at any regularly scheduled or properly noticed special meeting; and

WHEREAS, the Health Services Department was recently awarded additional funding from the California Department of Public Health for enhanced influenza activities as part of the COVID-19 Crisis Response for Fiscal Years 2020-2021 in the amount of Twenty Three Thousand Six Hundred Sixty Two Dollars and 0/100 cents \$23,662; and

WHEREAS, this funding will be used to support enhanced influenza activities as part of the COVID-19 Crisis Response related to operating, maintenance expenses and staffing to carry out various enhanced influenza activity requirements; and

WHEREAS, it is necessary to appropriate said revenue into the Lake County Department of Health Services Budget in order to use the funds.

NOW, THEREFORE, BE IT RESOLVED THAT, the Director of Health Services is hereby authorized and empowered to execute in the name of County of Lake, State of California all necessary certifications, contracts, payment requests, agreements, and documents hereto for the purposes of securing these funds to implement and carry out the purposes specified in the award letter.

BE IT FURTHUR RESOLVED THAT THE BOARD OF SUPERVISORS OF THE COUNTY OF LAKE, STATE OF CALIFORNIA, that it finds, determines, and hereby declares that the County of Lake Adopted Budget for Fiscal Year 2020/2021 is amended as follows:
