4	OFFICES LOCATED WITHIN AND SURROUNDING THE LAKE COUNTY COURTHOUSE BUILDING
5	WHEREAS, Section 24260 of the California Government Code provides in all Counties, County
6	officers shall keep their offices open for the transaction of business during such hours and on such days
7	as are fixed by the Board of Supervisors, by Ordinance or Resolution; and
8	WHEREAS, Lake County Code section 2-2.1, establishes all County offices must be open for
9	the transaction of business continuously from 8:00a.m. until 5:00p.m., every day except Saturdays,
10	Sundays, and holidays, unless otherwise provided by Ordinance; and
11	WHEREAS, on August 28, 2018, your Board adopted Resolution No. 2018-118, establishing
12	temporary office hours, authorizing closure to the public on Fridays as a six-month pilot, for County
13	offices located in and around the Lake County Courthouse building, due to high employee vacancy
14	rates, heavy workloads and disaster impacts; and
15	WHEREAS, your Board extended the authority granted by Resolution No. 2018-118 by
16	Resolution on: March 12, 2019 (Resolution No. 2019-35); September 10, 2019 (Resolution No. 2019-
17	136); March 10, 2020 (Resolution No. 2020-25); June 23, 2020 (Resolution No. 2020-79); and August 4
18	2020 (Resolution No. 2020-103).
19	NOW, THEREFORE, BE IT RESOLVED:
20	For the period of November 17, 2020 – March 31, 2021, all County offices located within the
21	Lake County Courthouse building at 255 N. Forbes St., Lakeport, and select surrounding and satellite
22	offices of the County of Lake, shall be open to the public for the transaction of business continuously
23	from 8:00a.m. until 5:00p.m., every day except Fridays, Saturdays, Sundays, and holidays. For weeks
24	that include one Monday or midweek holiday, designated offices shall be open to the public the other
25	four weekdays. It is this Board's intent to return to normal business hours as of April 1. Therefore,
26	beginning no later than January 8, 2021, all offices that remain closed on Fridays shall have at least one
27	staff member assigned to receive documents and meet other basic customer service needs in person
28	and via telephone on Fridays.
