**YOU ARE HEREBY** notified that the Lake County Animal Care & Control Director has determined that you are the owner/possessor of a VICIOUS ANIMAL(s) which is (are) described as:

1. Canine, Labrador, Silver, Male, 3 years, "Duce"
2. Canine, Doberman, Red/Brown, Female, 2 Years, "Daisy"

**The vicious animal is (are) located at:** 9003 Fairway Kelseyville, Ca 95451

**The findings of the investigation are as follows:**

1. 05/31/2019 – "Duce" and "Daisy" were reported At Large. NOV#94624 was posted for Vicious At Large posted. (2019-05-0173)
2. 10/18/2019 – Both dogs reported to be chasing Reporting Party while they were walking. (2019-10-0065)
3. 11/12/2019 – Both dogs were At Large and were willing to chase people. (2019-11-0038)
4. 02/03/2020- It was reported that both dogs were At Large and RP had to use mace to protect himself against the dogs in his front yard. NOV#93777 posted. (2020-02-0003)
5. 03/19/2020- Reported both dogs At Large chasing cats and people. (2020-03-0074)
6. 06/01/2020- Reported that both dogs were At Large Vicious and attacked an elderly man. Dog impounded for Bite Quarantine. NOV#93494 issued. (2020-06-0004)
7. 10/28/2020- Both dogs reported At Large. Chased RP up her driveway. NOV#95335 Posted for At large and Vicious At Large. (2020-10-0104)
8. 12/28/2020- LCSO called on 12/22/2020 stating woman was attacked by both dogs. NOV#96494 issued. (Case#223)

**Vicious Animal Defined by Lake County Code Section 4-14.1:**

1. An attack, without provocation which requires a defensive action by any person to prevent bodily injury and/or property damage in a place where such person is conducting himself lawfully and peaceably.
2. An attack, without provocation, on another animal or livestock which occurs off the property of the owner of the attacking animal.
3. An attack, without provocation, that results in an injury to a person in a place where such person is conducting himself lawfully and peaceably.
4. Any behavior, without provocation, that constitutes a physical threat of bodily harm to a person in a place where such person is conducting himself lawfully and peaceably.

**Therefore, the Director of Animal Care & Control has imposed the following conditions:**

1. Written proof (a true copy) of a public liability policy in the single incident amount of \$50,000 for bodily injury or death of any person(s) or for damage to property which may result from ownership or maintenance of such animal. Such insurance policy shall provide that no cancellation of the policy be made unless ten (10) days written notice is first given to the Lake County Animal Care & Control Department.
2. Posting of "Beware of Dog" signs on all sides of the property.
3. Obtain and keep current at all times, a County of Lake dog license, rabies vaccination, and have canine microchipped for purposes of identification. Microchip number to be given to Animal Care & Control within 15 days of service.
4. Construction of a 10'x10'x6' chain link kennel with concrete floor, padlocking gate and solid roof to provide shelter from the elements and confinement of said canine(s). This kennel needs to be located in a secure area of the property so that members of the public cannot obtain access.
5. Canine(s) is only allowed off of property for necessary medical appointments, and at no other time shall it be allowed off the property.
6. Photographing of canine(s) for identification purposes.
7. Canine(s) to be kept at **9003 Fairway Kelseyville, Ca 95451** and Animal Care & Control will be notified within 10 days of any change in ownership or residence to include new address, phone, and/or owner if ownership is transferred.
8. To be transported for vet appointments only, canine(s) shall be muzzled and on a six foot (6') maximum leash, with a responsible adult over the age of 18 years in control of that leash at all times.
9. If Duce is to return home or have a new known address, you must notify Animal Care and Control within 10 days. In cases of new ownership or residence, information including address, phone number and/or owner must be provided.

**YOU ARE FURTHER NOTIFIED that you must comply with the Abatement Order within 5 (five) days of this notice or file a request for a hearing before the Lake County Board of Supervisors. Filing a timely appeal will result in a stay of the Abatement Order, until a determination is made by the Lake County Board of Supervisors pursuant to Code Section 4-14.4 (d) of the Lake County Code.**

**If after 5 (five) days the Lake County Animal Care & Control Department has not received proof of compliance with the Abatement Order or notification that an appeal has been filed, the Animal Care & Control Department will take possession of the animal and dispose of it as necessary, up to and including euthanasia.**

**If you choose to comply with this order but need more than 5 days, we will grant up to 2 (two) weeks to comply, but no longer than 01/13/2021 5pm. If you have not complied by this time you will forfeit ownership of the animals.**

**FAILURE TO COMPLY WITH AN ABATEMENT ORDER  
ONCE ESTABLISHED**

In the event that an owner or possessor fails to comply with an Abatement Order, The Animal Care & Control Director may take one or more of the following actions:

1. Issue a citation to the owner/possessor for a violation of the above code section. Each day that a violation occurs is a separate offense.
2. Refer the matter to the District Attorney or County Counsel for prosecution of the alleged violation or for the abatement of the public nuisance.
3. Impound the animal in accordance with County Code. The owner/possessor may redeem an impounded animal prior to its final disposition by the Animal Care & Control Director provided that the owner/possessor agrees to comply and is able to comply with the Abatement Order and has paid all applicable fees and charges. In the event the owner/possessor does not file a timely appeal or redeem the impounded animal with 14 (fourteen) days after a written notice has been sent to the last address of the owner as shown on the abatement record, notifying said owner that said vicious animal will become the property of the County of Lake and will be humanely destroyed unless redeemed within fourteen (14) days after the mailing date of the notice, the Animal Care & Control Director shall humanely destroy the subject vicious animal. Said written notice shall also advise the owner/possessor of their right to a hearing and an opportunity to be heard on the question of whether the animal should be become the property of the County of Lake and be humanely destroyed. The notice shall be served upon the owner/possessor either personally or by registered mail, return receipt requested.

Narrative: On December 22<sup>nd</sup> 2020, at 0941 I received a call from the Lake County Sheriff's Office Dispatcher. There was a report of a woman named Linda Roach who was attacked and bitten by a mastiff type dog while on her walk that morning. At 0946 I called the number provided and made contact with Jesse Roach who explained that while his wife was out on a walk that morning she was attacked by a neighbor's dog and had been knocked to the ground and was bitten. I asked if the dogs were currently still at large and he stated that they were not. I then asked if the bite had broken the skin and he stated

that it did not break the skin but his wife did sustain some bruising as a result. I then gave Mr. Roach my department issued cell phone number and asked if they could send me pictures of the wound sustained from the dog attack. I received the pictures of the bruising as well as pictures of the address where the dogs live from Linda's cell phone. The address shown in the pictures were that of 9003 Fairway Drive Kelseyville, Ca. 95453. I advised Mr. Roach that I recognized the address and was familiar with the dogs that reside at that property and I would be having myself or another officer follow up with him on the next business day. I let him know to contact us or the Sheriffs dispatch line should any other incidents arise. On 12/28/2020 I typed up case number 223 and it was dispatched to Officer Hailey Del Fiorentino.

Narrative: On 12/28/2020 I received a complaint regarding an incident that occurred on 12/22/2020. It stated "LCSO called and said a woman called in saying she was attacked by 2 canines belonging to a neighbor. Officer Leishman made contact with Linda and her husband. Picture of the bite were sent via text. Linda stated that it did not break the skin. I advised that witness statements would be provided so that a citation can be issued to the



owner of the dogs at 9003 Fairway drive.” At approximately 1355 I arrived at 9040 Fairway dr. where I contacted the victim, her husband and several of their neighbors. All parties wished to fill out witness statements regarding what had happened on 12/22/2020. Witness statements were provided, filled out and collected. At approximately 1600 I returned to the area and spoke to the dog owner, Diana Reams (Peterson) about what had occurred. She stated that she was not aware that her dogs had been loose or of the incident until two of the neighbors contacted her that same day. She stated that she doesn’t deny something happened especially considering the dogs prior history. She stated that she had gone out of town for the holiday and had taken K9 “Daisy” with her and left K9 “Duce” at home in case he needed to be impounded for a second Bite Quarantine. She then stated that when she returned home on 12/26/2020 the K9 was not at the residence and she has not been able to locate him. I issued NOV#96494 informing her of a Vicious Abatement investigation being pursued and for At Large and Vicious At Large. On 12/30/2020 I issued a Vicious Abatement Order to Diana Reams (Peterson).

They all also agreed that they would be willing to appear in order to have a Vicious Abatement placed on the K9s. Witness statements were collected and a Vicious Abatement investigation will be completed. I responded to 9003 Fairway later in the evening where I spoke to Diana Peterson now Diana Reams. She stated that she didn't know the 2 K9s were loose but doesn't dispute that something happened. She stated that 2 of her neighbors showed up after the incident and told her what happened. She left for the holiday to a relatives home. She took Daisy with her but left Duce at home with his current Rabies, License, and other information in case Animal Control came to either pick him up or place him on home quarantine for the bite. She stated that she had a friend coming to care for the dog everyday. She stated that the friend came on the 24th, saw the dog and fed him, she then stated that friend came on the 25th but was in a rush so fed the dog and left not seeing him.
