**Agreement Effective Date:** July 1, 2020

This Redwood Toxicology Laboratory, Inc. (RTL) Service Agreement ("Agreement") is made by and between RTL and County of Lake through its Department of Social Services ("Customer") as of the date first set forth above.

### **BACKGROUND**

RTL offers drug and alcohol laboratory testing services ("Services"), and instant, on-site device products ("Products"), described on Attachment A. Customer and RTL desire for RTL to provide the Services and Products to the Customer.

### **AGREEMENT**

RTL and Customer agree as follows:

#### **1) DRUG TESTING SERVICES**

- a. RTL will provide the Services, as described in this Agreement, in connection with Customer's drug and alcohol testing program. Drugs and panels to be tested by RTL are described in Attachment A.
- b. RTL will provide screening and confirmation Services for alcohol and drugs of abuse in urine and oral fluids. Screening and confirmation methodologies vary by drug or metabolite and are subject to change at RTL's discretion. The most current screening and confirmation methodologies by drug, metabolite and/or panel are provided on RTL's website. Costs for Services performed and supplemental fees are provided in Attachment A.
- c. RTL's standard service includes all urine collection and shipping supplies. Supplies include requisition forms, specimen collection bottles, security seals and pre-paid shipping labels or containers. All items shipped FOB Shipping Point. Shipping costs for outbound supplies and inbound specimens are provided in Attachment A.
- d. RTL will supply electronic reporting of laboratory results through our proprietary webpage at <https://toxaccess.redwoodtoxicology.com>. Fax summary and/or hard copy reports will be provided upon written request by Customer.
- e. Turnaround time for results varies by test and method. Timely receipt of the specimen at the lab may be impacted by weather or postal/courier service delays. Turnaround time may be delayed if RTL is in receipt of a specimen that shows signs of tampering or has illegible writing on the chain of custody or label. Below is an approximation of RTL's turnaround times:

#### **Urine Drug Testing**

- Negative results for basic *urine* tests (non-esoteric) are available within twenty-four (24) to forty-eight (48) hours after receipt of specimen(s) at RTL.
- Confirmed positive results or esoteric testing requiring GC-MS, LC-MS/MS, or GC-FID will be reported to authorized Customer personnel within seventy-two (72) to ninety-six (96) hours after receipt of specimen(s), or after receiving request for GC-MS, LC-MS/MS, or GC-FID confirmation.

### **Oral Fluid Drug Testing**

- Negative results for oral fluid drug screens are available within twenty-four (24) to forty-eight (48) hours after receipt of specimen(s) at RTL.
  - Confirmed positive results by GC-MS or LC-MS/MS will be reported to authorized Customer personnel within seventy-two (72) to ninety-six (96) hours after receipt of specimen(s), or after receiving request for GC-MS or LC-MS/MS confirmation.
- f. RTL will retain positive specimens for three (3) months.
- g. RTL will provide litigation packets and court representation/testimony at the prices outlined in Attachment A.

## **2) DRUG TESTING PRODUCTS**

- a. RTL will provide Products, as described in this Agreement, in connection with Customer's drug and alcohol testing program. RTL may substitute a generic (unbranded) Product of an identical configuration, at the same price, when branded devices are not available.
- b. Collection and shipping supplies are available for Products. Supplies include requisition forms, specimen collection bottles or beakers, security seals and pre-paid shipping labels or containers. Costs for these collection and shipping supplies are described in Attachment A.

## **3) PRICE, PAYMENT and RETURNS**

- a. **Price.** Customer agrees to pay RTL for Services and Products in accordance with the pricing provided in Attachment A. RTL may adjust the price for Services and Products by providing written notice to Customer at least thirty (30) days prior to adjustment.
- b. **Payment.**
- I. **Services:** RTL will bill Customer for Services on a monthly basis. Customer agrees to make payments to RTL within thirty (30) days from the date of invoice. Maximum compensation per year will not exceed \$28,000.
  - II. **Products:** RTL will bill Customer for Products upon shipment of order. Invoices for Products are sent separately from Services invoices. Customer agrees to make payments to RTL within thirty (30) days from the date of invoice.
- c. **Returns**
- I. Any order rejected by the Customer on the basis that the Product is either non-conforming or is defective may be returned to RTL for full credit or replacement as set forth below. All claims must be made within 30 days from date of invoice.
  - II. RTL will make commercially reasonable attempts to deliver product to the Customer as per the established delivery schedule. Customer must be present to accept delivery of product. Product that is undeliverable and returned to RTL because Customer refuses Products that have been inadequately packaged, the Customer will notify RTL's customer service department to log the complaint. Any costs associated with the return of Product due to Member absence or inability to accept delivery will result in Customer being charged for product.

## **4) WARRANTIES AND REMEDIES**

- a. **Warranties:** RTL warrants to the Customer:
- I. That the Products shall be free from defects in material and workmanship and shall be in conformity in all material respects with the product specifications throughout the duration of their stated shelf life.
  - II. That RTL has and shall maintain general and products liability coverage, in the amount RTL customarily maintains for the activities contemplated by this Agreement. Upon request by the Customer, RTL will forward a certificate of insurance evidencing the coverage additions and amounts.
- b. **Remedies and Liability:**
- I. In case that all or part of the delivered Products is found defective or otherwise in breach of any warranty given herein, RTL shall replace the Products and shall bear the relevant freight costs to the Customer, provided that the Customer shall promptly after discovery give notice of the defect or non-conformity to RTL. **THE PROVISIONS OF THIS CLAUSE SHALL BE THE CUSTOMER'S SOLE AND EXCLUSIVE REMEDY WITH RESPECT TO NON-CONFORMING PRODUCTS.**
  - II. If a shipment is found to have non-conforming Products, Customer reserves the right to withhold payment until said non-conforming Products are replaced by RTL. In the alternative, Customer may pay the invoice for the non-conforming Product prior to replacement and receive a credit for the amount so paid toward a subsequent order. In the event that non-conforming Products are accepted by Customer at a discounted price, credit will be applied to future orders.
- c. **Limitation of Liability:**

- I. RTL shall not be liable for any loss or damage resulting from the use, operation or performance of the Products or related in any way to their acquisition, regardless of the form of action, except for loss or damage caused by the sole negligence of RTL. **IN NO EVENT SHALL RTL BE LIABLE TO CUSTOMER FOR ANY SPECIAL, INDIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES OR ANY DAMAGES RESULTING FROM LOSS OF USE, INTERRUPTION OF BUSINESS, EVEN IF RTL HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. NOTWITHSTANDING THE FOREGOING, IN NO EVENT SHALL RTL'S LIABILITY TO CUSTOMER EXCEED THE VALUE OF PRODUCTS PURCHASED, (E.G. CUSTOMER'S COST OF GOODS), UNDER THIS AGREEMENT DURING THE PREVIOUS SIX (6) MONTH PERIOD.**

## 5) TERM

- a. **Term.** This Agreement becomes effective upon the 1<sup>st</sup> day of July, 2020 and will terminate on the 30<sup>th</sup> day of June, 2023.
- b. **General Termination.** Either party (the "Non-breaching Party") may terminate this Agreement immediately by written notice to the other party (the "Breaching Party") following the occurrence of any of the following events:
  - (i) The Breaching Party fails to make any payment required hereunder and such failure continues for a period of five (5) days after written notice of such breach;
  - (ii) The Breaching Party is in material breach of this Agreement (other than for nonpayment or for a violation of Section 6) and such breach is not cured within thirty (30) days after written notice thereof;
  - (iii) The Breaching Party breaches this Agreement in any respect more than two (2) times in any calendar year even if such breach is cured;
  - (iv) The Breaching Party becomes the subject of insolvency or bankruptcy proceedings, ceases doing business, makes an assignment of assets for the benefit of creditors, dissolves, or has a trustee appointed for all or a substantial portion of Breaching Party's assets;

## 6) MISCELLANEOUS

- a. **Indemnification.** Each party to this Agreement (the "Indemnifying Party") will defend, indemnify, and hold the other party to this Agreement and its affiliates, owners, officers, directors, agents, and employees (each, an "Indemnified Party" and collectively, the "Indemnified Parties") harmless from any claim, demand loss, damage, liability, or expense, including reasonable attorney fees and costs, however incurred, including those incurred at trial, in any bankruptcy proceeding, on appeal, and on any petition for review (collectively, "Damages") to the extent that Damages result directly or indirectly from a third party claim resulting from: (i) the Indemnifying Party's breach of its obligations under this Agreement; (ii) the material breach of a representation or warranty made by the Indemnifying Party in this Agreement; or (iii) the Indemnifying Party's negligence, gross negligence, or willful misconduct; provided, however, that the Indemnifying Party has no obligation to indemnify any Indemnified Party to the extent that Damages result directly or indirectly from the breach, negligence, gross negligence, or willful misconduct of the Indemnified Party.
- b. **Insurance.** The Insurance requirements identified in Attachment B are hereby incorporated into this agreement.
- c. **Notices.** Any notices hereunder shall be given in writing directed to the address of each party set forth on the cover page of this Agreement, or to such other address as either party may substitute by written notices to the other, and shall be deemed given: (i) if sent by U.S. mail, upon receipt as evidenced by a delivery confirmation receipt; or (ii) if sent by recognized courier service, upon receipt as evidenced by the courier's records.
- d. **Confidentiality.** The parties agree that records related to test orders and/or test reports (collectively the "Data") shall be regarded as confidential, and both parties shall handle and use the Data in a confidential manner, as well as comply with all applicable federal and state laws and regulations regarding the use and disposition of such Data. Both parties agree to consider the terms of this Agreement confidential and not disclose any information contained in this Agreement to any outside party unless required by applicable law.
- e. **Attorney Fees.** In the event of a default under this Agreement the defaulting party shall reimburse the non-defaulting party for all costs and expenses reasonably incurred by the non-defaulting party in connection with the default, including, without limitation, attorney fees. Additionally, in the event any suit or action is brought to enforce or interpret any of the terms of this Agreement, the prevailing party shall be entitled to recover from the other party all reasonable attorney fees incurred at trial, on appeal, and on any petition for review, together with such other expenses, costs, and disbursements as may be allowed by law.
- f. **Governing Law Jurisdiction.** This Agreement shall be governed by and construed in accordance with the laws of the State of Illinois, U.S.A. excluding its conflict of laws provision. The Parties consent to the exclusive jurisdiction and venue of the federal courts of the Northern District of Illinois and, if there is no jurisdiction in federal court, to the exclusive jurisdiction and venue of the state courts in Lake County, Illinois, U.S.A.

- g. **Counterparts.** This Agreement may be executed in counterparts, each of which shall be deemed an original, but both of which together shall constitute one and the same instrument.
- i. **Electronic Signature.** The parties agree that the electronic signature of a party to this Agreement shall be as valid as an original signature of such party and shall be effective to bind such party to this Agreement. The parties agree that any electronically signed document (including this Agreement) shall be deemed (a) to be "written" or "in writing," (b) to have been signed and (c) to constitute a record established and maintained in the ordinary course of business and an original written record when printed from electronic files. For purposes hereof, "electronic signature" means a manually signed original signature that is then transmitted by electronic means; "transmitted by electronic means" means sent in the form of facsimile or sent via the internet as a "pdf" (portable document format) or other replicating image attached to an e-mail message; and, "electronically signed document" means a document transmitted by electronic means and containing, or to which there is affixed, an electronic signature.
- h. **Force Majeure.** Neither party shall be liable for any delay or default in performing its obligations (other than payment obligations) if such default or delay is caused by any event beyond the reasonable control of such party, including, but not limited to, material or Products shortages, labor disturbances, epidemic, or other similar event. The party suffering such cause shall immediately notify the other party of the cause and the expected duration of such cause. If either party's performance is delayed by more than 60 days pursuant to these Sections, the other party may immediately terminate this Agreement by written notice given before the affected party resumes performance.
- i. **Non-assignment.** Customer may not assign, transfer, or sell (including by operation of law) its rights under this Agreement, or delegate its duties hereunder to any person including any affiliate of Customer, without the prior written consent of RTL. A transfer of a controlling interest in Customer shall constitute an assignment. Any purported assignment without RTL's consent shall be void and shall constitute a breach of this Agreement.
- j. **Entire Agreement; Modification; Waiver.** This Agreement contains the entire agreement between the parties. No modification of any of its provisions, or any future representation, promise, or addition, shall be binding upon the parties unless made in writing and signed by both parties. A waiver of any obligation Customer has under this Agreement shall be effective only if in writing signed by RTL. A waiver on one occasion shall not affect RTL's right to require strict compliance with this Agreement in the future.

The duly authorized representatives of the undersigned have executed and delivered this RTL Service Agreement as of the Effective Date.



Initial screening of standard laboratory tests at RTL will be performed by enzyme immunoassay (EIA). Screening and confirmation methodologies, as well as cutoff levels, vary by drug or metabolite and are subject to change at RTL's discretion. Panel codes and testing equipment are also subject to change. Drugs available in the standard panels vary by panel code.

When laboratory confirmation tests are requested following a screen, they will be performed on an independent portion of the original specimen using gas chromatography-mass spectrometry (GC-MS), liquid chromatography-tandem mass spectrometry (LC-MS/MS), or gas chromatography-gas flame ionization (GC-FID), depending on drug class. GC-FID is used only on samples requiring alcohol (EtOH) confirmation. Confirmation on positive screens for the drugs included in the panel are available at the prices listed above. Separate fees will be incurred for confirmations performed on drugs that are not part of a standard panel, and for designer or esoteric drugs. Confirmation methodologies, as well as cutoff levels, vary by drug or metabolite and are subject to change at RTL's discretion. Panel codes and testing equipment are also subject to change.

**Collection & Shipping Supplies**

RTL provides all necessary urine specimen collection kits and shipping supplies to its clients at no additional cost. For urine testing these supplies include:

- Urine specimen collection kits: beakers with built-in temperature strips and specimen bottles
- Specimen baggies with absorbent material
- Lab requisition (chain of custody) forms – pre-printed and/or self-print electronic collection
- Pre-paid FedEx or UPS lab packs or pre-paid U.S. mailer boxes

**Lab Supply Shipping and Handling:** Outbound lab supply orders will be charged on an 'at cost' basis. FOB Shipping Point.

**Specimen Shipment to RTL:** Next day air service of inbound specimens sent to RTL for testing is provided at no charge when five (5) or more urine and/or oral fluids specimens are sent in each FedEx overnight shipment. Any combination of urine and/or oral fluids devices may be shipped together via FedEx overnight service. Fewer than five (5) specimens sent to the lab by next day air service will be assessed a seven dollar (\$7.00) charge per shipment.



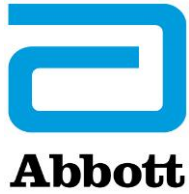

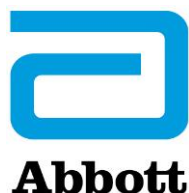
