Lake County CARES Act Small Business Grant Program

Funded by the County of Lake's CARES Act allocation

Small Business Grants, up to \$20,000

Grants paid for

- Lease/Mortgage - 42%
- Utilities - 22%
- Payroll - 33 %
- COVID related costs - 3%



Lake County CARES Act Small Business Grant Program

Eligible businesses:

- Annual Revenue - \$25k to \$1M
- Employees – up to 20 FTE
- Loss of revenue due to COVID

89 applications, 79 grants

Ineligible applications – 10

- Revenue was too high or low -5
- Could not verify loss of revenue -3
- Religious agency -1
- Closed with no plan to reopen – 1

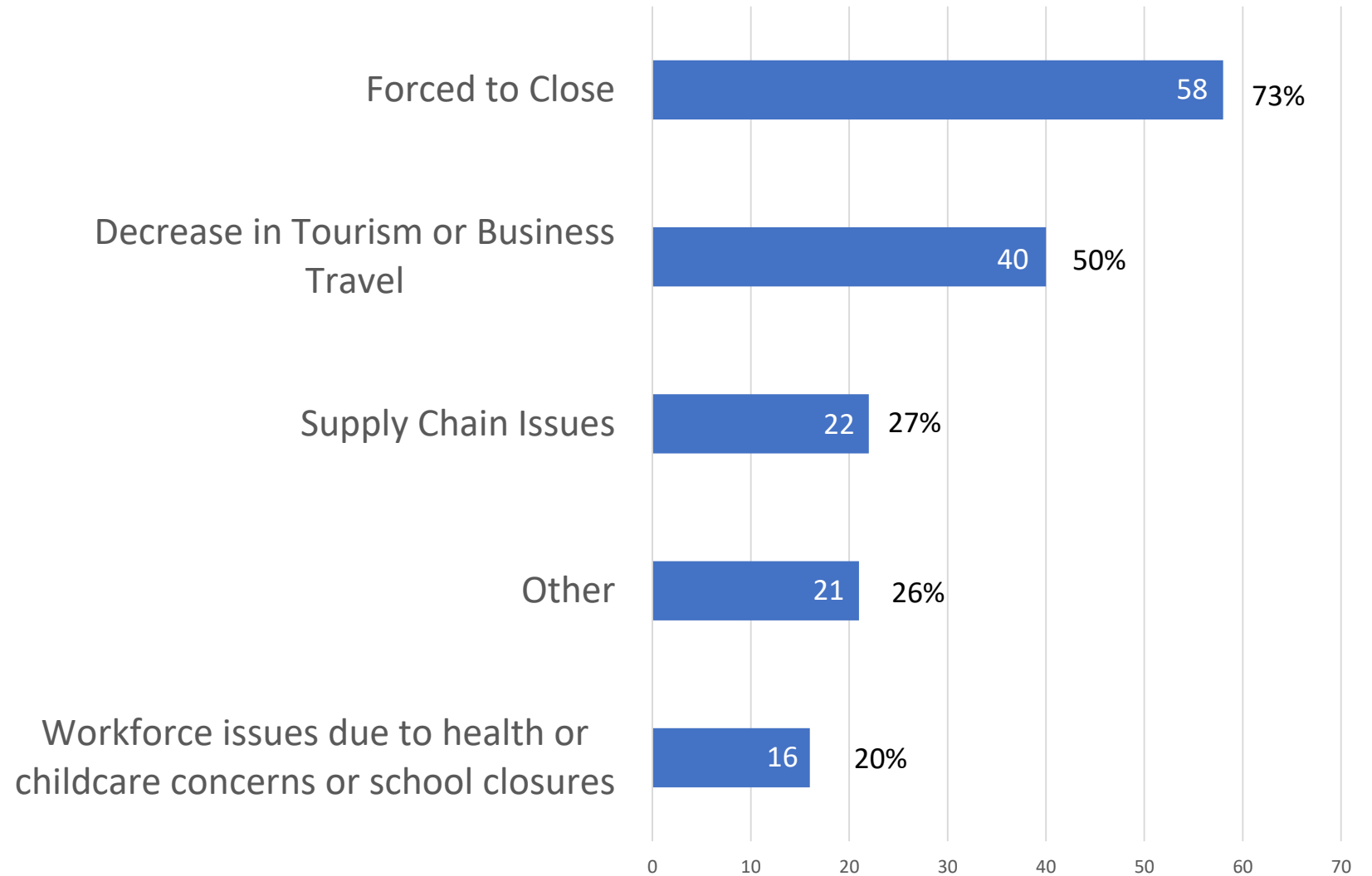
