BU 2704 – Office of Emergency Services

Office of Emergency Services is requesting a \$141,753 increase in revenue for FY20 Homeland Security funds.

BU 4011 – Public Health

Public Health is requesting a \$6,864 increase in revenue due to awarded funding being higher than expected.

APPROPRIATIONS

BU 1011 – Board of Supervisors

An additional \$2,500 is needed from the General Fund due to increased costs for Health/Life insurance.

BU 1012 – County Administrative Office

The Board of Supervisors approved the salary study in Fall 2020 which was implemented for 12/1/2020 payroll for most County employees, necessitating an additional \$77,719 General Fund contribution.

BU 1451 – Registrar of Voters

Registrar of Voters requires a \$32,719 increase in salary appropriations necessitated by the Board of Supervisors approved salary study, \$7,900 for Democracy Live annual contract renewal, and \$5,000 for candidate filing posting requirements.

BU 1671 – Buildings and Grounds

Buildings and Grounds is requesting an additional \$10,000 from the General Fund to cover the cost of an emergency HVAC replacement at the Lakeport Library. CannGrant funds in the amount of \$9,000 have been tentatively awarded and will be used for Courthouse Second Floor Counter Renovations to improve facility security.

BU 1904 – Information Technology

Information Technology has been tentatively awarded \$18,500 in CannGrant funds to be used for backup server appliance.

BU 1908 – Engineering and Inspection

Engineering and Inspection requires an additional \$7,467 from the General Fund to cover the increase in salaries which is attributed to the Classification and Compensation Study.

BU 1918 – Geothermal Resource Royalties

A decrease in Geothermal Resource Royalties appropriations is needed to cover the transfer of \$10,000 to Animal Care and Control which will be passed through to Animal Medical Clinic for salary increases attributed to the Classification and Compensation Study.

BU 2110 – District Attorney

The Board of Supervisors approved the salary study on October 20, 2020 which was implemented for 12/1/2020 payroll, necessitating an additional \$23,000 General Fund contribution.

BU 2201 - Sheriff-Coroner

Sheriff-Coroner has been tentatively awarded \$166,323 in CannGrant funds to be used for Law Enforcement/Code Enforcement Partnership. An additional \$210,000 is requested from Cannabis funds to provide P25 radios needed to comply with new requirements.

Marijuana Suppression is requesting a \$65,000 increase in appropriations for helicopter services.

BU 2301 – Jail Facilities
