AN ORDINANCE AMENDING SPECIFIED SECTIONS OF CHAPTER 25 OF THE LAKE COUNTY CODE RELATING TO FLOODPLAIN MANAGEMENT

1	THE BOARD OF SUPERVISORS OF THE COUNTY OF LAKE ORDAINS AS		
2	FOLLOWS:		
3	Section 1: Subdivision (b) of Section 4.3 of Chapter 25 of the Lake County Code		
4	is hereby amended to read as follows:		
5	"(b) Review, Request, and Use of Any Other Base Flood Data: When base		
6	flood elevation data has not been provided in accordance with Section 25-3.2,		
7	the Floodplain Administrator shall: (1) Obtain, review, and reasonably utilize any		
8	base flood elevation and floodway data available from a federal or state agency,		
9	of other source, in order to administer Section 25-5; (2) Request that the base		
10	flood elevation data is included for all new subdivision development		
11	proposals(including proposals for manufactured home parks and subdivisions)		
12	greater than 50 lots of 5 acres, whichever is lesser."		
13	Section 2: Subdivision (c) (4) is hereby added to Section 4.3 of Chapter 25 of the		
14	Lake County Code to read as follows:		
15	"(4) No later than six months after the new base flood elevation data becomes		
16	available, Floodplain Administrator shall notify the Federal Emergency		
17	Management Agency of the changes by submitting the data to the Administrator		
18	of said Agency"		

1	Section 3: Subdivision (b)(3) of Section 5.1 of Chapter 25 of the Lake County	
2	Code is is hereby amended to read as follows:	
3	" (3) With electrical, heating, ventilation, plumbing, and air-conditioning	
4	equipment and other service facilities that are designed to be elevated at least	
5	one foot above the base flood elevation."	
6	Section 4: Subdivision (c) (1) (iv) is hereby added to Section 5.1 of Chapter 25	
7	the Lake County Code to read as follows:	
8	" (iv) In all flood hazard zones flood resistance materials and methods shall be	
9	applied in enclosed areas below base flood elevation plus one foot."	
10	Section 5: Subdivision (a) of Section 5.6 of Chapter 25 of the Lake County Code	
11	is hereby amended to read as follows:	
12	"(a) Prohibit encroachments, including fill, new construction, substantial	
13	improvements, and other development within the adopted regulatory floodway	
14	unless it has been demonstrated through hydrologic and hydraulic analyses	
15	performed in accordance with standard engineering practice that the proposed	
16	encroachment would not result in any increase in flood levels within the	
17	community during the occurrence of the base flood discharge"	
18	Section 6: All ordinances or parts of ordinances or resolutions or parts of	
19	resolutions in conflict herewith are hereby repealed to the extent of such conflict and no	
20	further.	
21	Section 7: The proposed ordinance is exempt under CEQA Guidelines section	
22	15061(b)(3) because it can be seen with certainty that the project will have no	
23	significant effect on the environment.	

1	Section 8: This ordinance shall take effect and be in force thirty (30) days after		
2	its passage, and prior to the expiration of fifteen (15) days from the passage thereof,		
3	shall be published once in the Record-Bee, a newspaper of general circulation, printed		
4	and published in the County of Lake.		
5	The foregoing Ordinance was introduced before the Board of Supervisors of the
