Amendment No. 1 TO THE AGREEMENT BETWEEN COUNTY OF LAKE AND LAKE COUNTY OFFICE OF EDUCATION-SAFE SCHOOLS HEALTHY STUDENTS PROGRAM FOR SCHOOL-BASED SPECIALTY MENTAL HEALTH SERVICES FOR FISCAL YEAR 2020-21.
