

**Amendment No. 1 TO THE AGREEMENT BETWEEN COUNTY OF LAKE AND LAKE
COUNTY OFFICE OF EDUCATION-SAFE SCHOOLS HEALTHY STUDENTS
PROGRAM FOR SCHOOL-BASED SPECIALTY MENTAL HEALTH SERVICES FOR
FISCAL YEAR 2020-21.**

This Amendment No 1 to Agreement is made and entered into this 1st day of February, 2021 by and between the County of Lake, hereinafter referred to as "County," and Lake County Office of Education, hereinafter referred to as "Contractor," collectively referred to as the "parties."

RECITALS

WHEREAS, the parties hereto have entered into an Agreement dated July 1, 2020 under which contractor will provide school-based specialty mental health services to the residents of Lake County; and

WHEREAS, the parties now desire to amend that agreement to allow for reduction of compensation to be paid for services rendered during the contract period; and

NOW, THEREFORE, the parties hereto agree to the following Amendment to the Agreement:

3. COMPENSATION. Contractor has been selected by County to provide the services described hereunder in **Exhibit A**, titled, "**Scope of Services.**" **Compensation to Contractor shall not exceed Two Hundred Five Thousand Dollars (\$205,000.00).**

The Parties agree that all other terms and conditions of the original Agreement shall remain in full force and effect.
