Thank you for the opportunity to review the proposed Huttopia-Six Sigma resort located at 13372 Spruce Grove Rd, Lake County. The project is located on the Six Sigma Ranch and Winery property, about 4.5 miles SE of Lower Lake and 5.5 miles NE of Hidden Valley Lake. Access is via a private driveway that connects to Spruce Grove Rd, a paved County road. Spruce Grove Rd intersects SR 29 in two, improved locations (1-LAK-29-13.466 and 18.746).

The project proposes to develop a lodging/recreational resort with 129 tent/cabin sites, on-site staff housing, and a central hub for support, recreational and service facilities. This project is scaled back from a previous (2018) development proposal for 154 tent/cabins. Caltrans reviewed the 2018 project, its traffic study, and had no comments.

Mr Roberts,

I am a trustee for a parcel of abutting residential land (ASMT# 012-047-020-000) directly uphill from the proposed Huttopia glamping project at Six Sigma in Lower Lake. The county invited us to comment on a request for a Major Use Permit to allow a large "glamping" development, Huttopia Six Sigma Glamping Project: Major Use Permit UP 18-24; Initial Study IS 18-2; Lot Line Adjustment LLA 20-04, etc.

We object to this development for reasons listed below, and additional unlisted reasons we hope to be allowed to air in the future.

TRAFFIC: Spruce Grove Road is sole public access and egress from the proposed development. It is a quiet, rural, single lane, marginally maintained road with few or no guard rails, precipitous dropoffs, hairpin curves, dozens of blind spots, plentiful deer, huge oak trees and flammable brush impinging directly, onto the pavement, seasonal bicycle, horse and agricultural traffic, not a single bail point or alternative through egress in case of fire, a 55 mph speed limit as i am told by CHP, and is totally surrounded on both sides by miles of highly fueled wildland that has not burned in many decades. in short, if we who live there navigate it with the caution of long useage, sometimes unsuccessfully, how will hundreds of strangers on holiday fare? See our comment on fire egress, below, for more detail.

Spruce Grove Road is inherently unsafe as it stands; making it more so by doubling traffic with drivers unfamiliar with its peculiarities, and likely intoxicated on their holidays camping at a winery, is unwise, and asking for additional accidents and fatalities.

NOISE POLLUTION: The proposed "glamping" facility will be located at the head of the valley of Asbil brook, a natural ampitheater. Sounds project up and down the valley sides as in an auditorium. Normal conversations can be understood a half mile away; the sounds of tires on gravel on Six Sigma's access road a half mile away are easily and commonly mistaken for tires coming up our driveway, a hundred feet away. With few exceptions out neighbors are quiet and reasonable.

Six Sigma is not so considerate. It has a history of hosting huge public events in the area under consideration here, events featuring heavy traffic, cheering crowds, electrically amplified announcers and canned mucic, all seemingly designed to disrupt the quiet tenor of the community and annoy the neighbors. Our polite objections to the endless clamor are ignored. We put up with it because of the charitable and community nature of the events and, lasting only several days a few times each year, their temporary nature. A permant, year-long, commercial "glamping" venture, however, is quite another story. It will ruin the quiet enjoyment of our property, and decimate our property value. Would you want it in your backyard?

WILDFIRE: Considering the number and ferocity of wildfires in the county--- two weeks ago, for instance, the LNU fire almost burnt through the proposed "glamping" site--- one would expect the county to have second thoughts about allowing yet more people into the middle of unburned wildlands with only one narrow way out. I personally evacuated from our land here north along Spruce Grove Road during the Valley fire. The traffic of Hidden Valley Lake people running away from this fire was desperate, wall-to-wall, and stop and go. It took 5 minutes before somebody even let me out of the driveway. Normally the drive from the entrance of Six Sigma to Rt 29 takes about 5 minutes. That day it took 32 minutes, with no breakdowns or abandoned vehicles slowing or stopping our snail-like progress. Meanwhile, the fire behind adjacent hills appeared to be blazing down on us.

And Six Sigma wants to add another hundred or so vehicles to this, just to make more money?

Will these "glampsites" have campfires? At what time of year? Will our land be downwind? Will we be notified? Who will supervise this and how? Who will be responsible? Our housesite is DIRECTLY uphill from the proposed project, the worst direction possible for wildfire. ANY additional public usage increases the chance of fire. Can we even afford additional insurance?

PRIVACY: Six Sigma has a history of not maintaining their livestock fences. Their animals get loose by the dozen, damage our land, break out waterlines, empty our water storage, destroy our compost piles, damage the pavement on Spruce Grove Road, turn beautiful watercourses into mudslides. Responsible people at Six Sigma take hours to locate and make little or no effort to fix the damage their animals cause. We were offered a "sorry" and bottle of wine. This attitude toward their neighbors does not bode well for our future relations with hundreds of "glampers"--- curious, bored strangers on holiday who easily mistake somebody's backyard for inviting wilderness.

Generally speaking, we like our quiet, rural neighborhood just like it is. If we easily tolerated noise and light pollution, traffic and commercial hijinks, we wouldn't be building here.
