

Amendment No 3 to the Emergency Occupancy Agreement for use of the Kelseyville Motel

This Amendment No. 3 to Agreement is made and entered into this 6th day of April, 2021 by and between the COUNTY OF LAKE, a political subdivision of the State of California (hereinafter referred to as "COUNTY") and Kelseyville Motel (hereinafter referred to as "CONTRACTOR").

RECITALS

WHEREAS, the parties hereto have entered into an Agreement dated July 18, 2020 under which CONTRACTOR will provide Motel Rooms for Emergency Occupancy to COUNTY; and

WHEREAS, the parties desire to amend the number of block rooms in Agreement.

NOW, THEREFORE, the parties hereby agree as follows:

1. Section - Description- Subsection A – Rooms for Residential Occupancy is hereby amended to read:

The County shall reserve a block of two (2) rooms, and pay for said block of rooms, whether occupied or not, at the rate set forth in the original Agreement. The County will also be allowed to rent additional rooms as needed at the same rate set forth in the original Agreement.

The Parties agree that all other terms and conditions of the original Agreement shall remain in full force and effect.
