

**Amendment No. 4 to the Agreement with Evan Bloom, MD, MPH, INC to Assist the Lake County Public Health Officer During the COVID-19 Crisis Response**

This Amendment No. 4 to Agreement is made and entered into this 25<sup>th</sup> day of May, 2021 by and between the COUNTY OF LAKE, a political subdivision of the State of California (hereinafter referred to as "COUNTY") and Evan Bloom, MD, MPH (hereinafter referred to as "CONTRACTOR").

**RECITALS**

WHEREAS, the parties hereto have entered into an Agreement dated January 28, 2021, under which CONTRACTOR will provide Medical Consultation to Assist the Lake County Public Health Officer During the COVID-19 Crisis Response to COUNTY; and

WHEREAS, The Agreement was amended on April 6, 2021, to allow CONTRACTOR to be designated as to act as alternate Public Health Officer in special circumstances; and

WHEREAS, The Agreement was again amended on April 22, 2021, to extend the term, maximum compensation of the original agreement, and adjust compensation rates while acting as alternate Public Health Officer; and

WHEREAS, The Agreement was further amended on May 5, 2021, to raise the maximum compensation; and

WHEREAS, Parties wish to further amend the Agreement as to Compensation and Term; and

NOW, THEREFORE, the parties hereby agree as follows:

**Section 2 – TERM is hereby amended to read:**

This Agreement shall commence on January 23, 2021, and shall terminate on June 30, 2021.

**Section 3 – COMPENSATION is hereby amended to read:**

Compensation to CONTRACTOR shall not exceed Sixty Thousand Dollars (\$60,000.00) for the term of this Agreement.

The Parties agree that all other terms and conditions of the original Agreement shall remain in full force and effect.


