RESOLUTION AUTHORIZING CANCELLATION OF CAPITAL IMPROVEMENT RESERVE DESIGNATIONS IN THE AMOUNT OF \$11,000 TO PAYOFF THE LOAN ACQUIRED FOR THE LAMPSON FIELD RUNWAY PAVEMENT REHABILIATION PROJECT

WHEREAS, Government Code Section 29125, 29126, 29126.1, and 29130 of 1 the Government Code provide authority for the Board of Supervisors to transfer and 2 revise appropriations, cancel unused appropriations, transfer unused appropriations to 3 contingencies, reduce estimate and cancel and appropriate designations and reserves 4 5 other than the general reserve; and 6 7 WHEREAS, the Department of Public Works, Lampson Field Capital Projects. Fund 923 has received a loan from Fund 153 in the amount of \$910,000; and 8 9 WHEREAS, the Department of Public Works, Lampson Field Capital Projects is 10 required to pay back the loan by the end of FY 2020/2021; and 11 12 WHEREAS, Lampson Field Capital Projects, Fund 923 has paid back a portion 13 of the loan, \$400,000, leaving a balance of \$510,000 on the loan; and 14 15 WHEREAS, Lampson Field Capital Projects, Fund 923 reserves need to be 16 reduced in the amount of \$11,000, in order to have enough funds to pay off the 17 18 remainder of loan; and 19 WHEREAS, Lampson Field Capital Projects, Fund 923 Capital Improvement 20 Reserves designation has sufficient funds to meet this decrease of reserves; and 21 22 NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors, County 23 of Lake, State of California, that the following revisions to the Fiscal Year 2020/2021 24 25 Adopted Budget of the County of Lake, including reserves, are hereby ordered and approved: 26 27 /// /// 28 /// 29 /// 30 /// 31 /// 32 33 ///
