TENTH AMENDMENT TO THE AGREEMENT BETWEEN THE COUNTY OF LAKE AND CERNER CORPORATION FOR ANASAZI SOFTWARE AND SUPPORT SERVICES FOR FISCAL YEAR 2020-2021 AND 2021-2022

THIS TENTH AMENDMENT for Anasazi Software services ("Agreement") is entered into the 1st day of July 2020, by and between the County of Lake, a political subdivision of the State of California ("the County"), and Cerner Corporation, ("the Contractor").

WHEREAS, County and Contractor entered into an Agreement for Anasazi software and services on June 17, 2006; and

WHEREAS, a First Amendment to the Agreement was made on May 25, 2011, by and between the County of Lake (hereinafter referred to as "County"); a Second Amendment to the Agreement was made on March 13, 2012; a Third Amendment to the Agreement was made on May 1, 2012; a Fourth Amendment to the Agreement was made on September 1, 2013; a Fifth Amendment to the Agreement was made on July 1, 2014; a Sixth Amendment to the Agreement was made on July 1, 2015; a Seventh Amendment to the Agreement was made on July 1, 2016; and an Eighth Amendment to the Agreement was made on July 1, 2017; a Ninth Amendment to the Agreement was made on August 28, 2018; and

WHEREAS, the parties now desire to amend the Agreement to adjust the total maximum compensation payable under the Agreement for Fiscal Years 2020-21 and 2021-22.

NOW THEREFORE, the parties hereto agree as follows:

"Total reimbursement by County payable under the terms and conditions of the Agreement for Fiscal Years 2020-21 and 2021-22 shall not exceed **Ninety Five Thousand Dollars (\$95,000.00)** per year. This amount is contingent upon funding availability through the State of California. County will notify Contractor within 15 business days if funding through the State of California is no longer available. Contractor will not be obligated under this contract to provide services without payment by the County.

EXCEPT AS SPECIFICALLY MODIFIED HEREIN, all other terms and conditions of the July 17, 2006 Agreement and the Amendments dated May 25, 2011, March 13, 2012, May 1, 2012, September 1, 2013, July 1, 2014, July 1, 2015, and July 1, 2016, and July 2017 shall remain in full force and effect.
