Re: Inmate Food Service - Request for Meal Price Adjustment

Dear Sheriff Martin:

It has been an honor and a pleasure to provide inmate food services at the Lake County Jail. As you will recall, effective August 1, 2021 our Agreement expires, but thereafter allows for annual extensions which may be exercised upon mutual consent of the parties. Moreover, the Agreement calls for meal prices to be adjusted annually, effective on the anniversary/renewal date, based on the change in the Consumer Price Index, Food Away From Home. I have attached a copy of the data released by the Bureau of Labor Statistics and as you will see, the relevant index increased by 3.8%.

Based on this 3.8% adjustment, I have prepared and attached two revised price per meal scales. The first, Schedule 1, includes the extended scale with the addition of a third sandwich which was agreed upon by the parties to address issues associated with the ongoing COVID-19 pandemic. I have also included Schedule 2, the price per meal scale without the \$0.06 adjustment for the third sandwich, which we will revert back to upon written notification by Lake County. As indicated above, both scales include the agreed upon 3.8% adjustment. Assuming this meets with your approval, please sign and return the enclosed Confirmation Copy of this letter.
