REZONING THE LANDS FOR THE BRAND FAMILY PARCEL MAP PROJECT

THE BOARD OF SUPERVISORS OF THE COUNTY OF LAKE ORDAINS AS FOLLOWS:

**Section 1:** Section 21-3.7 of Chapter 21 of the Ordinance Code of the County of Lake is hereby amended by the adoption of Sectional District Zoning Map Number 3.7.(b)1. \_\_\_\_\_; so as to Rezone 23987 & 24073 State Highway 29, Middletown, CA 95461 being further described as Assessor Parcel Numbers 013-028-81 & 013-028-82, Lake County Records, Lake County, California.

**Section 2:** The Board of Supervisors has reviewed and considered the environmental effects of the as set forth in the Initial Study and Mitigated Negative Declaration (IS 17-31) which was adopted for this rezoning and finds, on the basis of the initial study and any comments received, that there is no substantial evidence that the project will have a significant effect on the environment.

**Section 3:** This rezoning is consistent with the Lake County General Plan and the Middletown Area Plan as amended.
