AN ORDINANCE AMENDING SECTION 21-3.7 OF CHAPTER 21 OF THE
ORDINANCE CODE OF THE COUNTY OF LAKE BY ADOPTING A
SECTIONAL DISTRICT ZONING MAP NO. 3.7(b) 1.

REZONING THE LANDS FOR THE SIRI FAMILY PARCEL MAP PROJECT

THE BOARD OF SUPERVISORS OF THE COUNTY OF LAKE ORDAINS AS FOLLOWS:

Section 1: Section 21-3.7 of Chapter 21 of the Ordinance Code of the County of Lake is hereby amended by the adoption of Sectional **District Zoning Map Number 3.7.(b)1.**; so as to Rezone **4436 Lakeshore Boulevard, Lakeport, CA 95453** being further described as **Assessor Parcel Number 029-141-22**, Lake County Records, Lake County, California.

Parcel Number	Current Zoning Designation	Proposed Zoning Designation
029-141-22	"R3- SC-FF-WW" (High Density Residential – Scenic Combining – Floodway Fringe - Waterway)	"R1-SC-FF-WW" (Low Density Residential — Scenic Combining – Floodway Fringe - Waterway)

All as shown on that certain map known as **Sectional District Zoning Map Number 3.7(b)1.**; a true and correct copy of said map is marked **Attachment 2**, attached hereto, and by this reference made a part thereof.

Section 2: The Board of Supervisors has reviewed and considered the environmental effects of the Rezone, subject to the Conditions of Approval and as set forth in the Initial Study and Mitigated Negative Declaration (IS 19-41) that was prepared for this project.

Section 3: This rezoning is consistent with the Lake County General Plan and the Lakeport Area Plan as amended.

Section 4: All ordinances or parts of ordinances or resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict and no further.

Section 5: This ordinance shall take effect on the _____ day of _____, 2021 and within fifteen (15) days after adoption of the ordinance, the Clerk to the Board of Supervisors shall publish a summary of the ordinance with the names of those supervisors voting for and against the ordinance and the Clerk shall post in the office of the Clerk to the Board of Supervisors a certified copy of the full text of the adopted ordinance along with the names of those supervisors voting for and against the ordinance.
