7 THE BOARD OF SUPERVISORS OF THE COUNTY OF LAKE ORDAINS AS FOLLOWS:

8 **Section 1:** Section 21-3.7 of Chapter 21 of the Ordinance Code of the County of Lake is hereby amended  
9 by the adoption of Sectional **District Zoning Map Number 3.7.(b)1. \_\_\_\_\_**; so as to Rezone **4436 Lakeshore Boulevard,**  
10 **Lakeport, CA 95453** being further described as **Assessor Parcel Number 029-141-22**, Lake County Records, Lake  
11 County, California.

16 true and correct copy of said map is marked **Attachment 2**, attached hereto, and by this reference made a part  
17 thereof.

18 **Section 2:** The Board of Supervisors has reviewed and considered the environmental effects of the  
19 Rezone, subject to the Conditions of Approval and as set forth in the Initial Study and Mitigated Negative  
20 Declaration (IS 19-41) that was prepared for this project.

21 **Section 3:** This rezoning is consistent with the Lake County General Plan and the Lakeport Area Plan as  
22 amended.

23 **Section 4:** All ordinances or parts of ordinances or resolutions or parts of resolutions in conflict herewith  
24 are hereby repealed to the extent of such conflict and no further.

25 **Section 5:** This ordinance shall take effect on the \_\_\_\_\_ day of \_\_\_\_\_, 2021 and  
26 within fifteen (15) days after adoption of the ordinance, the Clerk to the Board of Supervisors shall publish a summary
