Now, therefore, be it resolved and ordered, that Lake County Special Districts is hereby authorized to carry out the Project, enter into a funding agreement with the State Water Resources Control Board, and accept and expend State funds for the Project; and

Be it further resolved and ordered, that the Lake County Special District's Administrator, or designee, is hereby authorized and designated to sign, for and on behalf of CSA-21, North Lakeport Water, the funding agreement for the Project and any amendments thereto; and

Be it further resolved and ordered, that the Lake County Special District's Administrator, or designee, is hereby authorized and designated to represent CSA-21, North Lakeport Water in carrying out CSA-21, North Lakeport Water's responsibilities under the funding agreement, including approving and signing invoices and requests for reimbursement of Project costs.

Be it further resolved and ordered, that any and all actions, whether previously or subsequently taken by Lake County Special District's which are consistent with the intent and purposes of the foregoing resolution, shall be, and hereby are, in all respects, ratified, approved and confirmed.
