## Amendment No. 1 to Agreement for Recruitment Services for Lake County Public Health Officer

## **RECITALS**

WHEREAS, the parties hereto have entered into an Agreement dated March 11, 2021, under which CONTRACTOR will provide Public Health Officer (PHO) Recruitment services to COUNTY; and

WHEREAS, the parties are now in the third round of recruitment for PHO and while consulting fees are fixed, additional expenses are being incurred for a third round of advertising including geofencing, digital media, job boards and print; and

WHEREAS, the parties desire to amend the Agreement to extend the term and compensate for the additional costs.

NOW, THEREFORE, the parties hereby agree as follows:

Paragraph 2, entitled, "TERM", is hereby amended to read as follows:

"2. TERM. This Agreement shall commence on March 11,2021, and shall terminate on December 31, 2021, unless earlier terminated as hereinafter provided. In the event County desires to temporarily continue services after the expiration of this Agreement, such continuation shall be deemed on a month-to-month basis, subject to the sarne terms, covenants, and conditions contained herein."

Paragraph 3, entitled "COMPENSATION", is hereby amended to read as follows:

"3. COMPENSATION. Contractor has been selected by County to provide the services described hereunder in Exhibit "A" (Scope of Services), attached hereto. Compensation to Contractor shall not exceed twenty-eight thousand dollars (\$28,000). The County shall compensate Contractor for services rendered, in accordance with the provisions set forth in Exhibit "B" (Fiscal Provisions), attached hereto, provided that Contractor is not in default under any provisions of this agreement.

Paragraph IX of Exhibit D, entitled "Contractor's March 3, 2021 Proposal is hereby amended to read as follows:

"SERVICE COST - FULL SCOPE SEARCH SERVICES: **Consulting Services**, Phases I - IV in the proposal's scope of work and includes possible travel to client's location (or coordination of virtual meetings) - \$19,500. **Expenses**: Includes

possible travel to client's location (or document shipping fees/delivery charges to facilitate virtual meetings), advertising (may include print and postage), brochure design, panel packet content, delivery charges, fees for background and reference checks - \$8,500."

The Parties agree that all other terms and conditions of the original Agreement shall remain in full force and effect.
