8.2 9:06 A.M. - Swearing in of newly appointed Deputy Sheriff David Pike

Sheriff Martin introduced Deputy Sheriff David Pike and administered the Oath of Office. The Supervisors each thanked Deputy Sheriff Pike for his service to Lake County.

8.3 9:10 A.M. - Presentation of Proclamation Designating the Week of October 1-7, 2017, as National 4-H Week in Lake County, California

Supervisor Brown read the proclamation into the record and presented it to the attending members of the local 4-H clubs. 4-H member Erin Evans spoke.

County Administrative Officer Carol Huchingson presented the item to the Board. Lake County Chamber of Commerce Chief Executive Officer Melissa Fulton spoke.

Chair Smith asked if anyone present wished to speak. No one wished to speak and the public input portion of the item was closed.

9.1 Supervisors' weekly calendar, travel and reports

9.2 Consideration of and Report/Status Update on Hoberg's Valley Fire Clean-up of Structural Debris, Soil and Concrete Sampling, and Erosion Control

Environmental Health Director Ray Ruminski presented the item to the Board. Scott Scalenger from Hoberg's Historical Association was present and reported on the status of the ongoing clean-up. Mr. Scalenger said there are 10 yards of toxic soil to clear from the property and are waiting for a permit number from Environmental Health to complete this portion of the clean-up. The wood processing is 90% complete at this time. Construction debris is currently being removed and they are hoping to recycle the concrete, wood, etc. Erosion control is in the works, as a culvert under the State highway distributes large amounts of water flow across the property. The project is on track to be finished by the October 15, 2017 deadline. Supervisor Brown informed Mr. Scalenger of a returned check for payment to the County landfill. Mr. Scalenger was unaware of the situation and will follow up with Hoberg's financial office and stated that staffing and financial capability have been holding up the completion of the project.

Chair Smith asked if anyone present wished to speak. No one wished to speak and the public input portion of the item was closed.

Status update only. No action taken.

9.3 Consideration and Discussion of the Need for Development of Standardized Language which would allow Local Disaster Survivors to Reside (or Continue to Reside) in RV's, MHU's (Manufactured Housing Units) Purchased from FEMA, and other Types of Non-Standard Housing for a Time Limited Period

Chair Brown presented the item to the Board. Community Development Director Bob Massarelli, Senior Planner Michalyn DelValle and Chief Building Official Brian Lee were present and spoke. A brief Powerpoint presentation was given. County Administrative Officer Carol Huchingson also spoke. Hope City Kevin Cox was present and spoke. FEMA has offered to donate trailers to Hope City to be used for fire survivors.

Chair Smith asked if anyone present wished to speak and Joan Moss spoke. No one else wished to speak and the public input portion of this item was closed.

There was Board consensus to facilitate an extension of time for local disaster survivors to continue to reside in non-standard housing and develop findings to justfy exceptions that would include a termination date.
