Executive Summary:

The California Department of Water Resources (DWR) has regularly met with the County staff and supervisors over the last several months to discuss the potential impacts of PG&E's Potter Valley Project decommissioning proposal.

Recently, DWR identified a grant funding opportunity for Lake County to examine the potential water supply impacts accompanying the possible loss of Lake Pillsbury. There is approximately \$700,000 available to conduct a technical assessment to estimate the impacts of the decommissioning process, including dam removal, and evaluate potential adaptations, provide cost estimates, and evaluate other strategies for implementing mitigations. The information this assessment would provide is critical for upcoming State and Federal proceedings pertaining to the decommissioning, as
